

I protest the LADWP Water Rate Ordinance!

In the private sector when businesses have an economic downturn, what do they do to restructure their businesses and increase their efficiency in order to grow their business and show earnings to its stockholders? They reduce expenses and some of the ways this is done is by laying off personnel and closing offices or stores. In January 2016, Macy's announced that it will be closing stores, laying off employees by eliminating more than 4,500 positions, offering voluntary separation opportunities to approximately 165 senior executives that meet age and service requirements. Macy's is not alone. Walmart is closing 154 stores and laying off 10,000 in the United States. JC Penney's is closing 47 stores and cutting approximately 5,500 jobs. The list keeps growing and includes other types of businesses as the economy continues to decline as stock and oil prices fall.

In 2015, it was announced that there would be no increase in Social Security Payments in 2016 for recipients. I am a widow and live on my social security. I need to budget my money to pay for the necessities in life which include but are not limited to food, medicines, real estate taxes, telephone service, gas service and yes LADWP water, electric and sanitation services. When my expenses increase, where do I get my money from to cover the additional expenses. I can't I need to cut back and that is often a most difficult decision. Do I cut back on my food, my medicines (some of which are not covered by insurance and/or AARP), cut back on the heat in winter or on air conditioning in the summer? It is not an easy decision.

When the drought came, LADWP forced us to conserve water. If you went over your limit you were financially penalized. The unintended consequences due to the water

conservation was the reduced monies paid to the LADWP. So now, LADWP wants us to pay twice. The first penalty levied against all LADWP users if you use more than the allotted amount. The second penalty is a rate increase to make up for the revenue lost due to water conservation. The LADWP does not care about the citizens of Los Angeles as it is not accountable to us and has refused to provide any accounting as to how and where our tax money is spent. This needs to stop and it needs to stop immediately.

Now, the time has come and reality sets in as the LADWP must learn that the Los Angeles City Tax Payer is not an infinite source of money but a finite source that has reached its limits. Just as businesses and people have to cut back and make sacrifices so too must the LADWP. It needs to identify where it wastes money, and it does, and eliminate those areas. Layoff employees, yes, public employees should not and cannot be a protected class. It needs to reduce layers of management by merging departments together or eliminating them altogether and reduce both its management and work force. Another area that LADWP needs to address and re-structure are Union Contracts.

It is no secret, the City of Los Angeles is broke and there are unfunded liabilities. In the not too distant future, if the City of Los Angeles is not actively proactive, it will follow in the wake of bankrupt cities like Stockton and San Bernardino California.

The time has come for the City of Los Angeles and its various Department to realize that the tax payer has been and continues to be over taxed and can no longer afford the out of control and wasteful spending that continues to run rampant. Just as the citizens of the City of Los Angeles must make sacrifices so must the LADWP.
