**BABCNC Board Resolution for Community Impact Statement on
LADWP Ballot Measure Council File 16-0093**

Dear Honorable Councilmembers Herb Wesson, Paul Koretz and Members of City Council:

We, Travis Longcore, Ph.D., and Nickie Miner, declare that we are the President and Vice President respectively of the Bel Air Beverly Crest Neighborhood Council, and that on February 24, 2016, a Brown Act noticed public meeting was held by the Bel Air Beverly Crest Neighborhood Council, and, with a quorum of 15 board members met, the Bel Air Beverly Crest Neighborhood Council unanimously approved the following:

The BABCNC calls on the City Council to follow the recommendation in the Industrial, Economic and Administrative Survey to form "a committee to examine governance reforms for the Department with the explicit task of reporting its findings and recommending a measure for the 2017 ballot." This Governance Committee should be involved in drafting any memorandums and other information from the beginning and include at least two members from the Neighborhood Councils who are familiar with the operations and finances of DWP. The DWP Oversight Committee recommends that there be a robust and transparent discussion and debate before any measure is placed on the ballot for voter approval or rejection.
