

**ORDINANCE NO.** 188613

An ordinance amending Subsection D of Section 10.4.5 of Division 10.4, Article 10, Chapter 1A of the Los Angeles Municipal Code to update the method used to make annual adjustments to applicable park fees.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection D of Section 10.4.5 of Division 10.4 of Article 10 of Chapter 1A of the Los Angeles Municipal Code is amended to read as follows:

**D. Indexing.**

Any fee imposed by this Division (*Parks Fees & Dedications*) shall be adjusted on July 1st of each year by a percentage equal to a weighted average of:

1. The percentage change in the Construction Cost Index for Los Angeles, as published by Engineering News Record, or its successor publication, for the 12-month period between March in the year in which the adjustment is made and the month of March in the immediately preceding year; and
2. The percentage change in the Federal Reserve Economic Data All-Transactions House Price Index for Los Angeles-Long Beach-Glendale, CA (MASD) as published quarterly by the Federal Reserve Bank of St. Louis, or its successor publication, from the fourth calendar quarter most recent to the year in which the adjustment is made to the fourth calendar quarter immediately preceding it.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
