PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT relative to amendments to the Airport Peace Officers Representation Unit Memorandum of Understanding 30 (MOU 30).

Recommendation for Council action:

APPROVE the accompanying amendments to the Airport Peace Officers Representation Unit MOU 30, as approved by the Executive Employee Relations Committee, authorizing the addition of the newly created classification of Airport Police Specialist (Class Code No. 3236-0), as described in Amendment No. 1 attached to the Council file; and, a change to Article 5.3 B (Holiday Premium Pay) for officers who work a regular shift on a holiday, as described in Amendment No. 2 attached to the Council file.

Fiscal Impact Statement: The City Administrative Officer (CAO) reports that no additional costs are associated with the accretion of Airport Police Specialist to the bargaining unit. The additional cost of the holiday premium pay will be approximately \$10,000 per year. All costs associated with these proposed changes will be borne by the Los Angeles World Airports.

Community Impact Statement: None submitted.

Summary:

At a regular meeting on January 17, 2018, the Personnel and Animal Welfare Committee considered a CAO report regarding MOU 30 of the Airport Peace Officers Representation Unit. After an opportunity for public comment, the Committee recommended on consent to approve the recommendation in the CAO report. This matter is now submitted to the Council for consideration.
