

RECOMMENDATION

That the Council authorize the General Manager of the Department of Transportation to execute the proposed Sixth Amendment to Contract C-128057 with AAMCOM, LLC for continued operation and management of the Cityride Paratransit Program and Transit Technology Service Program through August 31, 2026, subject to the approval of the City Attorney as to form and legality.

SUMMARY

In accordance with Executive Directive 3, the Department of Transportation (LADOT) requests to execute the proposed Sixth Amendment with AAMCOM, LLC for continued operation and management of the Cityride Paratransit and Transit Technology Service programs for one additional year, from September 1, 2025 through August 31, 2026, for a total term of 10 years, and increase the maximum compensation by \$1,517,970 to a total maximum compensation of \$12,408,973. This Amendment will allow the Department to finalize the new proposed contract for the operation and management of LADOT's Transit Customer Service Center and Cityride Administration, including Cityride Paratransit and Transit Technology Service Program management services. The Department anticipates submitting it for processing in a few months.

On August 17, 2016, the Mayor and City Council approved a five-year contract with Keolis Transit Services, LLC (Keolis) dba MyTransit Plus to provide Cityride program registration and related technical support services for the Cityride Paratransit Program. On September 16, 2019, Keolis informed LADOT that it would be moving its headquarters from Los Angeles to Boston and would no longer provide services. Keolis requested that the contract be reassigned to AAMCOM LLC (AAMCOM), which LADOT accepted since AAMCOM had prior experience and involvement in transportation and transit projects and programs with other local and regional government agencies in California. On December 10, 2019, the City Council approved execution of the First Amendment to Contract C-128057 to reassign the contract from Keolis to AAMCOM (C.F. 16-0804).

On June 1, 2021, LADOT entered into a Second Amendment to replace the Program Budget Summary. On August 31, 2021, LADOT entered into the Third Amendment to extend the term of the contract by 12 months until August 31, 2022 and to increase the cost by \$1,287,365 for a total not to exceed amount of \$7,299,588. On November 29, 2022, LADOT entered into the Fourth Amendment to extend the term of the contract by 12 months until August 31, 2023, increase the cost by \$1,368,570 for a total not to exceed amount of \$8,668,158, and incorporate the updated Standard Provisions for City Contracts. On December 29, 2023, LADOT entered into a sole source contract with AAMCOM (C-144812) for a six-month term with a maximum compensation amount of \$911,116 to ensure no gap in service and to expedite payment for services performed since the expiration of Contract C-128057 on August 31, 2023. On May 17, 2024, LADOT entered into a Fifth Amendment to extend the term of the contract by 17 months, through August 31, 2025, and increase the cost by \$2,222,845, for a total not to exceed amount of \$10,891,003. The LADOT reported that actual expenditures for Year 9 of the contract is \$1,235,294, which is \$227,022 lower than the Year 9 contract amount of \$1,462,316.

The proposed Sixth Amendment extends the term of the agreement by one year, through August 31, 2026, and increase the cost by \$1,517,970, for a total cost of \$12,408,973. Additionally, it includes updated Standard Provisions for City Contracts and Exhibit I – Program Budget Summary and Program Budget Details. Sufficient funds exist within the City Proposition A Local Transit Assistance Fund to cover the cost of Year 10 of the contract.

In accordance with Los Angeles Administrative Code Section 10.5(a), Council approval of this proposed amendment is required as the proposed total term of the contract exceeds three years.

FISCAL IMPACT STATEMENT

There is no General Fund impact. Sufficient funds exist within the City Proposition A Local Transit Assistance Fund to support the cost. The City's obligation is limited to the availability of appropriations.

FINANCIAL POLICIES STATEMENT

The recommendation complies with City Financial Policies as sufficient appropriated funds exist to support the proposed expenditures.

BETWEEN THE CITY OF LOS ANGELES AND AAMCOM LLC
FOR THE OPERATION OF THE
CITYRIDE PARATRANSIT PROGRAM COORDINATOR AND TRANSIT TECHNOLOGY SERVICE PROGRAM**

THIS SIXTH AMENDMENT to Agreement C-128057 between the City of Los Angeles (hereinafter referred to as the "CITY"), a municipal corporation, acting by and through the Los Angeles Department of Transportation (hereinafter referred to as "LADOT"), and AAMCOM LLC, a California Limited Liability Company (hereinafter referred to as "CONTRACTOR"), collectively referred to as "Parties" and individually as "Party," is entered into with reference to the following:

WHEREAS, LADOT desires to continue the obtained services for the management of the Cityride Paratransit Program Coordinator and Transit Technology Services; and

WHEREAS, on April 15, 2016, LADOT issued a Request for Proposals (RFP), locally and nationally for companies interested in providing service in accordance with City Charter §372, seeking qualified Contractors to perform said services; and

WHEREAS, LADOT determined that the CONTRACTOR has the management and technical expertise and other assets necessary for the operation of the Cityride Paratransit Program Coordinator Transit Technology Service; and

WHEREAS, on August 24, 2016, the Parties entered into Agreement C-128057 (the "Agreement"), wherein the CONTRACTOR, Keolis Transit Services, LLC, agreed to provide services requested in the time and manner set forth in the RFP and Proposal incorporated into the Agreement; and

WHEREAS, Keolis Transit Services, LLC relocated its headquarters and requested the CITY approve reassignment of Agreement C-128057 to AAMCOM LLC; and

WHEREAS, on February 27, 2020, LADOT entered into the First Amendment to Agreement C-128057 (C.F. 16-0804), to reassign the Agreement to AAMCOM LLC as the CONTRACTOR to the Agreement, update the CITY'S Standard Provisions for City Contracts (Rev. 10/17) [v.3], and add other contracting language as required by ordinance of all CITY contracts; and

WHEREAS, on June 1, 2021, LADOT entered into the Second Amendment to Agreement C-128057 (C.F. 16-0804), to replace the Program Budget Summary to carry over and reallocate residual funds from the previous contract year to the next contract year throughout the remaining contract term; and

WHEREAS, on August 31, 2021, LADOT entered into the Third Amendment to Agreement C-128057 (C.F. 16-0804), to extend the term of the Agreement for a period of twelve (12) months until August 31, 2022, and to increase funding by one million two hundred eighty-seven thousand three hundred sixty-five dollars (\$1,287,365) for a total not-to-exceed amount of seven million two hundred ninety-nine thousand five hundred eighty-eight dollars and twenty cents (\$7,299,588.20); and

WHEREAS, on November 29, 2022, LADOT entered into the Fourth Amendment to Agreement C-128057, to extend the term of the Agreement for a period of twelve (12) months until August 31, 2023, increase funding by one million three hundred sixty-eight thousand five hundred seventy dollars (\$1,368,570) for a total not-to-exceed amount of eight million six hundred sixty-eight thousand one hundred fifty-eight dollars and twenty cents (\$8,668,158.20); update the Standard Provisions for City Contracts (Rev. 10/21) [v.4], and add contracting language as required by ordinance of all CITY contracts; and

WHEREAS, on December 29, 2023, LADOT entered into a Sole Source Agreement C-144812 with AAMCOM, LLC, to expedite payment for services provided since the expiration of C-128057 on August 31, 2023, and minimize impacts of employee furloughs due to the delay in invoice payments; and

WHEREAS, on June 5, 2024, LADOT entered into the Fifth Amendment to Agreement C-128057, to extend the term of the Agreement for a period of five (5) months from the date of attestation by the Los Angeles City Clerk to August 31, 2024, with an option to extend for an additional one (1) year from September 1, 2024 to August 31, 2025, for a total of at least one (1) year five (5) months, increased funding by two million two hundred twenty-two thousand eight hundred forty-five dollars (\$2,222,845) for a total not-to-exceed amount of ten million eight hundred ninety thousand nine hundred ninety-five dollars (\$10,891,003), and replace Exhibit I – Program Budget Summary (Form C-II) and Program Budget Details (Form C-II-A); and

WHEREAS, LADOT is in the process of awarding a new contract for these services, but requires continuation of the current Agreement until the new contract award so there is no disruption of service; and

WHEREAS, LADOT desires in this Sixth Amendment to Agreement C-128057, to a) extend the term of the Agreement for one (1) year from September 1, 2025 to August 31, 2026; b) increase funding by one million five hundred seventeen thousand nine hundred seventy dollars (\$1,517,970) for a total not-to-exceed amount of twelve million four hundred eight thousand nine hundred seventy-three dollars (\$12,408,973); c) revise and incorporate Attachment A -Standard Provisions for City Contracts (Rev. 1/25 [v.2]); and d) replace Exhibit I – Program Budget Summary (Form C-II) and Program Budget Details (Form C-II-A); and

NOW, THEREFORE, in consideration of the above premises and the mutual covenants and agreements herein contained, the Parties agree as follows:

1. **Section II, TERMS OF CONTRACT**, Subsection A, Contract Period, Paragraph 1 is hereby deleted in its entirety and replaced by the following:

A. Term and Termination

1. Term: This Sixth Amendment extends the term of this Agreement for one (1) year, from September 1, 2025, through August 31, 2026, for a total term of ten (10) years from September 1, 2016, through August 31, 2026, unless otherwise terminated in accordance with the termination provisions herein.

2. **Section IV, COMPENSATION**, Paragraph A is hereby removed in its entirety and replaced as follows:

The CITY shall pay the CONTRACTOR an amount not to exceed twelve million four hundred eight thousand nine hundred seventy-three dollars (\$12,408,973), for the complete and satisfactory performance of the terms and conditions of this Agreement for the entire term of this Agreement, from September 1, 2016, through August 31, 2026.

During the period of September 1, 2025, through August 31, 2026, the CITY agrees to pay the CONTRACTOR an amount not to exceed one million five hundred seventeen thousand nine hundred seventy dollars (\$1,517,970), for the complete and satisfactory performance of the

terms and conditions of this Agreement, as outlined in Exhibit 1 - Program Budget Summary (Form C-II) and Program Budget Details (Fom C-IIA).

3. Effective the date of attestation by the Los Angeles City Clerk of this Sixth Amendment, all references to any version of the Standard Provisions for City Contracts throughout this Agreement and all previous Amendments are hereby deleted and replaced with Attachment A - Standard Provisions for City Contracts (Rev. 1/25 [v.2]).
4. **Attachment A, Standard Provisions for City Contracts**, is hereby replaced in its entirety by the Attachment A -Standard Provisions for City Contracts (Rev. 1/25 [v.2]) attached hereto and incorporated herein.
5. **Exhibit I – Program Budget Summary (Form C-II) and Program Budget Details (Form C-II-A) effective September 1, 2023**, is hereby replaced in its entirety by the Exhibit 1 – Program Budget Summary (Form C-II) and Program Budget Details (Form C-II-A) effective September 1, 2025, attached hereto and incorporated herein.
6. Except as herein amended, all other terms and conditions of this Agreement shall remain unchanged.
