Section 1.0 Subsection 7.2 of Section 7.0, <u>Payment for Services</u>, is deleted in its entirety and replaced with the following:

"For all Services rendered under this Contract, all costs, direct or indirect, and all expenses incurred by Consultant pursuant to this Contract, the total compensation to be paid to the Consultant for all services rendered under this contract shall not exceed the total sum of Eight Million Dollars (\$8,000,000.00) for the term of the contract"

Section 2.0 It is understood and agreed by and between the parties hereto that, except as specifically provided herein, this First Amendment shall not in any manner alter, change, modify, or affect any of the rights, privileges, duties or obligations of either of the parties hereto under or by reason of Contract No. DA-5131 and except as expressly amended herein, all terms, covenants, and conditions of Contract No. DA-5131, and all amendments thereto, shall remain in full force and effect.
