Comments for Public Posting: I stand with STAND LA in requesting that the City of Los Angeles (1) Require that all oil wells within 2500' of inhabited areas be sunsetted within 5 years via a just transition using the oil company's revenue to retrain their workers to do so. (2) That all oil and gas storage and/or production facilities provide adequate bonding to protect residents within a half-mile of their operations by demanding an escrow account funded by 1/4 of their quarterly gross revenue. And if not needed to address costs of a disaster or other risks incurred, that the money remains in escrow to be used for properly plugging their abandoned & end-of-life wells. (3) If any owner/ operator cannot afford to carry out the above two requirements, they thereby go into receivership to address these critical needs for the well-being of the climate, of their workers, and of all who reside in or come within a half-mile of their operations.
