The Harbor city Neighborhood Council urges the city to:

- move quickly to adopt this ordinance that will zone out oil drilling city-wide.
- The city should commit to shortening the phase-out period from the existing 20-year timeframe and phase out oil wells on a schedule like Culver City's five-year phase-out. A city's amortization study found that most older wells had already paid off their costs. Los Angeles is performing its own amortization study as required by council motion 17-0447.
- The city should mandate oil companies pay for comprehensive well plugging for active and unactive wells and site clean up after oil sites are shut down, and promote community-benefiting redevelopment based on feedback from impacted residents.
- The city code should maintain health existing protections during the phase-out period and immediately prohibit dangerous activities like acidization.
- Engage public health experts to report on community impact
  of <u>highly toxic substances such as hydrofluoric acid</u> used in oil
  wells, and draft regulations to prohibit any that pose a significant
  risk to the surrounding neighborhood.
- Encourage redevelopment of well sites in a way that benefits the community, with neighborhood input.
- Encourage South Coast AQMD to hire more investigators in each council district to respond in a timelier manner, to perform proper investigations.
