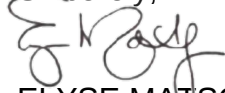

1. Tillman Water Reclamation Plant Advanced Water Purification Facility Project from the California State Water Resources Control Board (SWRCB) - Water Recycling Funding Program (WRFP); and

RECOMMENDATION

1. Approve and forward this report, with its transmittals, to the Mayor and City Council with the recommendation that the City Council, subject to concurrence of the Mayor, ratify CF 17-1335 which authorized the Director and General Manager of LA Sanitation and Environment (LASAN) to apply for, negotiate, accept, execute, and submit all documents, including, but not limited to, applications, agreements, amendments, and payment requests etc., subject to the approval of the City Attorney as to form, which may be necessary to secure grant funds for the Donald C. Tillman Water Reclamation Plant Advanced Water Purification Facility (DCTWRP AWPf) Project from the California State Water Resources Control Board (SWRCB) - Water Recycling Funding Program (WRFP)
2. Request that the City Council, subject to the concurrence of the Mayor, adopt the accompanying updated Authorizing Resolution (Transmittal 1) identifying the Director of LASAN as the authorized representative to the SWRCB WRFP

DISCUSSION

On June 26, 2024, the enacted State Fiscal Year 2024-25 California State Budget appropriated approximately \$69.8 million in General Funds for water recycling projects through the SWRCBs WRFP. The City of Los Angeles was awarded \$3 million in grant funds in the State of CA Clean Water State Revolving Fund 2024-25 Intended Use Plan (IUP) for the DCTAWPF.

The DCTAWPF Project represents a significant step toward enhancing water sustainability and resilience in Los Angeles. Located at the Donald C. Tillman Water Reclamation Plant (DCTWRP), this project includes several components to optimize water purification and facility functionality. The primary feature is a state-of-the-art advanced water purification treatment train capable of processing up to 19 million gallons per day (MGD) of tertiary effluent, producing 15.5 MGD of purified water for groundwater replenishment via the Hansen Spreading Grounds. Additional elements include the construction of a larger maintenance and warehouse facility (MWF) to support new plant processes, the temporary ancillary warehouse facility (AWF) to ensure operational continuity during MWF reconstruction, and a new primary equalization basin (AWEB) to maintain steady water flow to the advanced purification systems. By addressing key water

resource challenges, this project advances the City of Los Angeles' goal to improve local water reliability, reduce reliance on imported water, and align with long-term sustainability objectives such as those outlined in the Green New Deal.

The original authority to submit an application to SWRCB WRFP was received through CF 17-1335, approved on February 2, 2018. CF17-1335 also approved an Authorizing Resolution. LASAN has submitted all application documents to SWRCB, but they have requested an updated Authorizing Resolution before they can execute a grant agreement. Per the IUP, a grant agreement must be executed by March 31, 2025 to be considered for WRFP grant funds in SFY 2024-25.

PROGRAM REVIEW COMMITTEE (PRC) APPROVAL

The DCTWRP AWP was approved by the PRC on December 20, 2023 for the construction amount of \$529,000,000.

STATUS OF FINANCING

There is no impact to the General Fund. The total front funding for this grant is not to exceed \$3,000,000. No funding is required at this time. Specific funding information will be provided at the time of approval of the grant. Funding sources may include, but are not limited to the Fund No. 761, Sewer Capital Fund.

Reimbursements from the SWRCB will be deposited into the Fund No. 761, Sewer Construction Maintenance Fund, Department No. 50, Departmental Revenue Source Code 336104 - Other State Grants -Miscellaneous Programs.

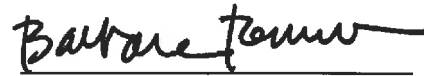

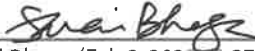

WHEREAS, LA Sanitation and Environment (LASAN), acting on behalf of the City of Los Angeles (City), intends to apply to the State Water Resources Control Board (SWRCB) to obtain financial assistance through the Water Recycling Funding Program for the DCTWRP Advanced Water Purification Facility Project (the Project);

WHEREAS, the SWRCB requires that the City's legislative body designate a City representative (Authorized Representative) and authorize the Authorized Representative to act on the City's behalf in submitting an application for financial assistance for the DCT AWPFF to the SWRCB.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Los Angeles as follows:

The Director and General Manager of the Bureau of Sanitation (Authorized Representative) is hereby authorized and directed to sign and file, for and on behalf of the Entity, a Financial Assistance Application for a financing agreement from the State Water Resources Control Board for the planning design and construction of the Project.

This Authorized Representative, or his/her designee, is designated to provide the assurances, certifications, and commitments required for the financial assistance application, including executing a financial assistance agreement from the State Water Resources Control Board and any amendments or changes thereto.

The Authorized Representative, or his/her designee, is designated to represent the Entity in carrying out the Entity's responsibilities under the financing agreement, including certifying disbursement requests on behalf of the Entity and compliance with applicable state and federal laws.

PUBLIC WORKS TRUST FUND (PWTF) LOAN AUTHORIZATION (\$750,000) FOR STATE OF CALIFORNIA GOVERNOR'S OFFICE OF LAND USE AND CLIMATE INNOVATION (LCI) EXTREME HEAT AND COMMUNITY RESILIENCE PROGRAM (EHCRP)

On July 2, 2024, the City Council approved the Board of Public Works (BPW), Climate Emergency Mobilization Office (CEMO) to apply for funding from the State of California Governor's Office of Land Use and Climate Innovation (LCI, *formerly OPR*)'s Integrated Climate Adaptation and Resiliency Program's (ICARP) Extreme Heat and Community Resilience Program (EHCRP) (C.F. No. 21-1015-S10). CEMO applied for this grant opportunity on May 6, 2024, in advance of the deadline.

RECOMMENDATIONS

In anticipation of receiving this grant award, and potentially starting work before the end of the current fiscal year, CEMO is requesting Board of Public Works (Board) authorization, subject to the Mayor and City Council approval, for the following:

1. AUTHORIZE a \$750,000 loan from the Public Works Trust Fund (Fund 834/Dept. 50), to provide cash flow and implement the "City of Los Angeles' first Heat Action and Resilience Plan (HARP)" in the Board of Public Works, and to be repaid from reimbursements received from the State; and,
2. AUTHORIZE the Board of Public Works, Director of Accounting, to transfer \$750,000 from available funds within the Public Works Trust Fund, Fund 834, Dept. 50 to the Board of Public Works, Fund 100, Department 74, Balance Sheet Account 2360 titled Advance from Other Funds, and increase appropriations by up to \$750,000 within the Board's Contractual Services account (003040) once a formal award letter and grant agreement are received and approved by Council; and,
3. AUTHORIZE the receipt of State grant funds from the State of California Governor's Office of Land Use and Climate Innovation to be deposited into the Board of Public

Works, Fund 100, Department 74, Revenue Source Code 5427, Reimbursements from Grants, and repay outstanding loan receivable, Balance Sheet Account 1370, Advance to Other Funds within the Public Works Trust Fund (Fund 834/Dept. 50) until full repayment is received, with final payment expected no later than June 30, 2027.

DISCUSSION

The Extreme Heat and Community Resilience Program funds and supports local, regional, and tribal efforts to reduce the impacts of extreme heat, while coordinating with the State's efforts to address extreme heat and the urban heat island effect. The Program also drives the State's work to implement California's Extreme Heat Action Plan, a comprehensive, coordinated effort across State agencies and local municipalities to advance equity, including reducing the economic and health disparities exacerbated by extreme heat. This program will also address historic underinvestment by embedding equity into the planning and implementation process including by encouraging communities to equitably plan for extreme heat events by centering the needs of community members most vulnerable to extreme heat.

CEMO's Heat Action and Resilience Plan (HARP) will be a community co-designed blueprint for the City and many regional cities. Los Angeles seeks to be the first city in California to have a Heat Action Plan. The HARP aims to eliminate preventable heat-related deaths and injuries in alignment with the core values of the State's plan, namely reducing health disparities, job creation, and multi-linguistic access. This model plan envisions healthy, thriving, heat-resilient communities and zero heat-related deaths. CEMO's Co-Applicant is the Community-Based Organization (CBO) Visión y Compromiso, who will lead the co-design of workshops, surveys, outreach, and educational materials with trusted partner networks. CEMO and Visión y Compromiso will establish a Community Advisory Committee (CAC) to represent the most heat-impacted areas (utilizing UCLA Heat Maps) along with a City Steering Committee (CSC) representing the City Departments with key heat mitigation roles in our stakeholder engagement efforts. This plan will also identify and map an inclusive community Heat Resilience and Resource Center Network and a community heat-health educator workforce. The HARP will strive to accelerate equitable investments to counteract heat and climate risks and exposures in the most vulnerable communities and bolster community resilience with City and State resources, services,

and infrastructure to create thriving communities long after the plan is completed, with embedded long-term civic oversight through the CAC.

The following are the tasks and phases outlined in the grant proposal, and will be instrumental to the HARP's completion and project success (subject to revision in actual grant agreement):

Task 1: Project Initiation: Set up City Steering Committee (CSC), Set up Community Advisory Committee (CAC), Develop Decision-Making Structure and Work Plan, Onboard Technical Consultant, Co-Design Community Engagement Process, Finalize Community Engagement Plan, Curate Heat Safety Curriculum.

Task 2: Engagement: Launch and Execute HARP CAC and CSC, Execute community co-designed public awareness Surveys, Focus Groups, and Workshops with/for frontline communities, Execute Peer-to-Peer Workshops.

Task 3: Plan Alignment: Qualitative Data Analysis from Surveys, Focus Groups, Polls, and Workshops, Compile and analyze Heat Risk Mapping, Align and Integrate with City plans, Draft Plan, Launch Initial Heat Dashboard.

Task 4: Process Evaluation: Evaluation and Analysis of Data from Engagement, Produce Process Report.

Task 5: Plan Completion: Share Final Draft with CAC, Publish Final Draft, Share Final Draft in Workshops, Collect Data, Finalize Changes, Produce Final Plan, Submit Final Plan for City Council Adoption, Distribute Adopted Plan and Dashboard to Public.

Also, as far as implementation, as per Track E of the future Heat Action and Resilience Plan, annual metrics will be tracked over a three (3) year period indefinitely through a platform created in Track E of the HARP. The results of the tracking will be made available to the public via an online dashboard and an annual distribution strategy. This will be expanded upon in a future grant agreement.

The proceeds from this grant program will be received on a reimbursement basis; therefore, CEMO is requesting a loan from the Public Works Trust Fund (PWTF) No. 834 in the amount of \$750,000 to provide front funding for "The City of Los Angeles' first Heat Action and Resilience Plan (HARP)" associated with the LCI ICARP EHCRP Grant Program. The proposed PWTF loan will provide general fund relief and allow BPW to implement and encumber funds as swiftly as possible to minimize impact to service deployment and job recruitment and placement.

The distribution should be allocated across three (3) separate fiscal years in order to ensure completion, and the first distribution should be authorized for \$100,000 before the end of Fiscal Year 24-25 in order to get the project started as soon as possible following Council approvals and agreed upon start-date.

PROGRAM ADMINISTRATION

The Climate Emergency Mobilization Office (CEMO), an office of the Board of Public Works, is designated as the City's fiscal and administrative lead for this grant program and referenced as BPW-CEMO in the grant application. BPW-CEMO will be responsible for adhering to the grant reporting requirements, including the submission of quarterly and annual reports on expenditures and program metrics.

FISCAL IMPACT STATEMENT

There is no impact to the General Fund. The Public Works Trust Fund (PWTF) will provide the \$750,000 loan to front-fund the Extreme Heat and Community Resilience Program (EHCRP). Loan repayment will be made as reimbursements from the State of CA Governor's Office of Land Use and Climate Innovation (LCI) are received on a quarterly basis. As of December 31, 2024, loans in the PWTF had a total outstanding balance of \$63.95 million. Not included in this amount are approved loans pending disbursement in the amount of approximately \$2.17 million. This brings the total of the balance from outstanding loans and those approved loans pending disbursement to \$66.12 million. Total deposits in the PWTF, as of December 31, 2024, were approximately \$164.50 million. This equates to a 40.20% loan-to-balance ratio (LTBR).

Once the additional loan in the amount of \$750K is added to the PWTF for the purposes of front funding this grant program, the outstanding loan balance will increase to approximately \$66.87 million, equating to a 40.65% LTBR (an increase of only 0.45% LTBR). The Board's LTBR target is at or below 25% but not to exceed 30%. However, the Board reserves the right to change the maximum threshold at its discretion. Funds will be disbursed and transferred from the PWTF No. 834, Dept. 50 to the General Fund, Fund 100, Dept. 74, Various Appropriation Accounts as described in Recommendation 2 of this report. If awarded, reimbursements are anticipated from the State of CA Governor's Office of Land Use and Climate Innovation (LCI) on a quarterly basis. The Board of Public Works expects full repayment of this loan by no later than June 30, 2027.

RECOMMENDATIONS

That the Council, subject to approval of the Mayor:

1. Authorize the General Manager of the Department of Recreation and Parks (RAP) and the Director of the Public Works (PW) Board or designees to prepare and submit grant applications for the California Governor's Office of Planning and Research (OPR), Integrated Climate Adaptation and Resiliency Program (ICARP), Extreme Heating and Community Resiliency Program (EHCRP) Round 1– FY 2023-24; and,
2. Instruct the RAP General Manager and the Director of the PW Board or designees, if the City is awarded the grants, to request authority to accept the grant awards and to request approval for any related actions to implement the grant awards.

SUMMARY

On January 29, 2024, the California Governor's Office of Planning and Research, Integrated Climate Adaptation and Resiliency Program (ICARP) released a notice of funding availability for the Extreme Heat and Community Resilience Program (EHCRP) Round 1 – FY 2023-24. The EHCRP will provide funding for planning and implementation projects to reduce the impacts of extreme heat and to build community resilience and/or frameworks for change and investment in local, regional, and tribal projects for strengthening communities that are vulnerable to heat, climate hazards, and adverse effects. The grant submission due date is April 24, 2024 and awards will be announced in the summer of 2024. The performance period is 30 months. There is no matching fund requirement or additional restrictions such as a limitation to the number of application submissions per entity.

The OPR will provide funding of up to \$20 million for the EHCRP Round 1 FY 2023-24 under the following categories:

Other Criteria

The EHCRP Round 1 – FY 2023-24 requires partnerships and community engagement. Applicants seeking large implementation and large planning grants should apply with a community-based non-profit organization (CBO) or coalition co-applicant.

RAP will identify a CBO subsequent to the application submission as allowable per the grant guidelines. CEMO has identified a CBO and co-applicant, Vision y Compromiso, to co-design the public engagement process, distribution of outreach materials, and serve as a Community Advisory Committee member.

Required Approval to Accept Award

In accordance with Los Angeles Administrative Code Section 14.6(a), all departments are required to seek Mayor and Council approval before accepting and receiving a grant award. It is therefore recommended that RAP and CEMO report back to the Mayor and Council upon award notification to request authority to accept and receive the grant award and confirm there is no additional General Fund impact.

FISCAL IMPACT STATEMENT
