HOLLY L. WOLCOTT CITY CLERK TRANSPORTATION COMMITTEE REPORT relative to establishing oversize vehicle parking restrictions on Barton Avenue between North Saint Andrews Place and North Western Avenue.

Recommendations for Council action, pursuant to Resolution (O'Farrell - Bonin):

- 1. RESOLVE, pursuant to Los Angeles Municipal Code Section 80.69.4 and California Vehicle Code Section 22507, to hereby prohibit the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 a.m. and 6:00 a.m. on Barton Avenue between North Saint Andrews Place and North Western Avenue.
- 2. DIRECT the Los Angeles Department of Transportation (LADOT), upon approval of this action, to post signs giving notice of a Tow Away, No Parking restriction for oversize vehicles on the street listed above in Recommendation No. 1.
- 3. AUTHORIZE the LADOT to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

<u>SUMMARY</u>

On March 6, 2018, Council considered Resolution (O'Farrell - Bonin) relative to establishing oversize vehicle parking restrictions on Barton Avenue between North Saint Andrews Place and North Western Avenue. According to the Resolution, there is an increased problem with oversize vehicles parking along this segment of Barton Avenue, where large vehicles park overnight and constrict travel lanes on the roadway, thereby creating dangerous situations. Council referred Resolution to the Transportation Committee for consideration.

At its meeting held March 28, 2018, the Transportation Committee recommended that Council approve the parking restrictions and related LADOT instructions pursuant to Resolution.
