PUBLIC SAFETY COMMITTEE REPORT relative to the permit requirement for temporary change of use for assemblage purposes and authority to approve or disapprove the crowd management and medical plans for the Los Angeles Fire Department (LAFD).

Recommendations for Council action:

1. APPROVE the Los Angeles Fire Department's (LAFD) report of March 6, 2018 relative to the permit requirement for temporary change of use for assemblage purposes and authority to approve or disapprove the crowd management and medical plans for the LAFD.
2. REQUEST the City Attorney to prepare and present an Ordinance within 30 days to amend Los Angeles Municipal Code, Section 57.4701, establishing a permit for temporary change of use (place of assemblage), adding additional requirements for a temporary change of use (place of assemblage), providing the LAFD the authority to approve crowd management plans and medical plans.

Fiscal Impact Statement: The LAFD reports that there will be no fiscal impact.

Community Impact Statement: None submitted.

SUMMARY

At the meeting held on May 9, 2018, your Public Safety Committee considered a Board of Fire Commissioners (Board) report relative to the permit requirement for temporary change of use for assemblage purposes and authority to approve or disapprove the crowd management and medical plans for the LAFD. The Board reports that the purpose of this proposed ordinance is to establish a formal approval process within the Fire Department for a temporary change of use (place of assemblage). This process will contain basic requirements for minimum fire/life safety. In addition, it will provide the LAFD the authority to approve or disapprove the crowd management and medical plans. After an opportunity for public comment was held, the Committee moved to approve the Board's recommendations, as detailed above. This matter is now forwarded to the Council for its consideration.
