potential health impacts to residents in the surrounding neighborhoods from air pollution from trucks. We are also concerned about project impacts including greenhouse gases, noise, lighting, and traffic. This warehouse project, if built, would

impose an environmental injustice upon the area. Install

heavy-duty electrical infrastructure to have capacity to charge at least 10 trucks, especially medium-duty electrical trucks which are currently in use. Install as many photovoltaic panels on the roof as will fit. Require that truck engines meet the latest California emission standards, rather than 2010. Do not allow truck traffic at night. Limiting night-time truck trips to "only" 105 trips between the hours of 10pm and 5am means that there would be, on average, a truck every four minutes. With 768 trips per day, trucks

would be arriving, on average, every 2 minutes.

I am writing in regard to the proposed Prologis Vermont and Redondo Project located at  $747-861\,\mathrm{W}$ . Redondo Beach Blvd in Los Angeles.

As one of the Fire Captains at Fire Station 79, which serves the Harbor Gateway community, I want to share some of the public safety concerns we've encountered near the project site. Recently, our station has seen an increase in fires occurring on or adjacent to this property, with arson being a primary cause. In one notable incident, we responded to a stolen vehicle that had been abandoned and deliberately set on fire on the nearby railroad tracks.

These recurring incidents pose serious safety risks to both the public and first responders, while also straining our station's resources and ability to serve the broader community effectively.

Activating and developing this long-vacant site presents a critical opportunity to improve public safety. I understand that the proposed project will include full-time security, improved lighting, and the presence of employees during both construction and operation. These elements will help deter the kinds of hazardous activity we've been seeing. Additionally, I was informed that a new fence will be installed around the Rosecrans Recreation Center and Park, which will provide an added layer of safety for nearby residents.

Transforming this site from a blighted, underutilized area into a secure and active development will undoubtedly benefit the neighborhood and ease the demands placed on emergency services.

Thank you for your time and your continued efforts. I support this project and hope to see it move forward to help make the community safer for all.

school, Rosecrans Recreation Center, Kei-ai South Bay
Healthcare Center. Air pollution impact from high levels of fine
particulate matter from diesel truck exhaust, tire residue, and
brakes (particulate matter is absorbed by the lungs and distributed
throughout the whole body leading to many illnesses such as lung
disease, heart disease, diabetes, dementia, and contributing to
early death); the current level of pm 2.5 for the area is already
high. Noise impact from trucks coming and going at all hours of
the night and day – interrupted sleep and high levels of noise have
a serious impact on peoples' health. Traffic impact at the Vermont
Avenue/Redondo Beach intersection and along Redondo Beach
Blvd. around Orchard Avenue and the 110 Harbor Freeway; the
Vermont Avenue/Redondo Beach Blvd. intersection is a key route
