MOTION

The Council District AB1290 Fund provides funding for redevelopment and community services in various Council Districts.

The Board of Public Works is coordinating the efforts of the Los Angeles Conservation Corps for a tree planting and maintenance project at the intersections of Winnetka and Roscoe and Winnetka and Saticoy in Council District 3. This effort is of special benefit for the residents of the City and for CD-3 and deserves financial assistance from the City.

Sufficient funds are available in the CD-3 portion of the Council District AB 1290 Fund for this purpose.

I THEREFORE MOVE that \$61,000 in the AB1290 Fund No. 53P, Account No. 281203 (CD 3 Redevelopment Projects - Services) be transferred / appropriated to the Board of Public Works Fund No. 100-74, Account No. 3040 (Contractual Services) for tree planting / maintenance at the intersections of Winnetka and Roscoe and Winnetka and Saticoy in Council District 3.

I FURTHER MOVE that the Board of Public Works Bureau of Accounting be authorized to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Motion.
