I am a resident of Koreatown and am on-board following the recent announcement regarding homeless housing near Wilshire and Vermont. I am disappointed that fellow residents of the building where I live are circulating flyers that say the city is building a homeless TENT ENCAMPMENT in that parking lot and "will not have control of alcohol and drugs." This flyer seems ill-informed and shortsighted. Is there a fact sheet that the City of L.A. has in simple language (and perhaps also in Korean) explaining that the sites in EVERY district are going to be supervised for three years with facilities that members of the homeless population can access? I find it difficult to understand the opposition to this facility. This is not a NIMBY issue. The homeless population is already in our backyard and they deserve to be treated with some compassion.

I would greatly welcome some bilingual literature that I could circulate among the residents of my building. The paranoia and hysteria is unfounded and detrimental to the effort to find a solution to this devastating issue that affects our city.



Cairo,

I thought you might like to know that our middle school and high school history classes have been studying homelessness. They've been polling teachers, students, and other adults to see what their perceptions are about the situation. The project convened on Thursday, when they all met in the Cocomanut Grove at RFK for an assembly about homelessness, which included a panel of homeless, formerly homeless, and homeless advocates.

I am told that later on that afternoon, some of the student made signs welcoming the new homeless shelter and went to Vermont to picket for a while. The move was impromptu, purely a spontaneous response.

This is such a contrast to the article that I read today in which "Koreatown residents" picketed against the shelter. To our kids, it seems like such an obvious social justice and human rights issue. I wonder if those against it (the names I read in the article were european in nature), who don't seem to empathize would be humbled if they knew that our community youth see the situation differently.

Dear City Council Member,

I am writing to you to urge you to vote in favor of the proposed shelter at 682 S. Vermont in Koreatown, and for the other bridge home sites across the city. As a neighbor of the Koreatown shelter site, I see this as an opportunity for the city to directly help my homeless neighbors. Koreatown is a neighborhood we love, a diverse community that has thrived in the face of adversity. Unfortunately, Koreatown, like much of Los Angeles, has faced growing problems due to the shortage of affordable housing.

The most visible and damaging of these consequences is the growing number of homeless people living on the streets. Koreatown currently lacks the facilities necessary to house even a small fraction of its homeless residents. As a result, my homeless neighbors face violence, exposure to the elements, and the everyday indignities of life without a home. In order to begin addressing this issue, I urge you to support the proposed plan for a temporary emergency shelter.

It is important that this project includes consideration for the cluster of problems that are often linked to homelessness, including mental health and addiction issues, exposure to violence, economic hardship, domestic abuse, illness, and disability. The city must ensure that residents of bridge home shelters are able to access the support services necessary to address difficult and interrelated problems. That is why I believe this location, which sits in the heart of the Koreatown community and at the intersection of a number of key transit corridors, will help ensure that residents are able to access not just the services provided by the shelter, but all of the services and opportunities offered by this city.

While Koreatown's residents and other shelter neighbors need to have a voice in this project, I reject the politics of fear that see the shelter as a threat to this neighborhood's safety and economic vibrancy. Koreatown has managed to grow and thrive, even as its homeless population has grown. The shelter in Koreatown, and others like it across the city, offer an alternative to this failed approach.

Shelter housing is not a burden to be carried by each community, but an opportunity to be part of the solution. 
