Pacific Palisades Community Council (PPCC) is the broadest-based Palisades organization and has been the community's voice since 1973.

PPCC strongly opposes the legalization of rooftop digital advertising on any vehicles, including taxicabs and other for-hire vehicles, in Los Angeles. Regarding CF 19-0104-S1, based on its prior public position PPCC opposes the creation of a program to allow rooftop digital advertising for any period of time on taxicabs or for-hire vehicles in the City.
