Subject: **ANNUAL UPDATES TO CITY EMERGENCY OPERATIONS PLAN AND ANNEXES**

In accordance with federal Homeland Security planning and grant eligibility requirements, the Emergency Management Department (EMD) has worked closely with emergency response and support departments this year to review, update and revise the City's Emergency Operations Plan (EOP) and a number of its hazard and function specific annexes and appendices. These revisions were approved by the City's Emergency Operations Board (EOB) and are submitted to the Mayor and Council as an information item summarizing plan changes made during the 2018 calendar year.
