

ORDINANCE NO. 186615

An ordinance amending Schedule "A" of Section 4.61 of the Los Angeles Administrative Code to amend the salary for the non-represented classification and pay grade of Senior Personnel Analyst II.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The following class position in Schedule "A" of Section 4.61 of the Los Angeles Administrative Code is amended as follows:

Sec. 2. Section 1 shall be operative on July 7, 2019.

Sec. 3. The following class position in Schedule "A" of Section 4.61 of the Los Angeles Administrative Code is amended as follows:

Sec. 4. Section 3 shall be operative on January 19, 2020.

Sec. 5. The following class position in Schedule "A" of Section 4.61 of the Los Angeles Administrative Code is amended as follows:

Class Code	Class Title	Salary Range, Amount, MOU No, or Ordinance No.
9167-2	Senior Personnel Analyst II	5372

Sec. 6. Section 5 shall be operative on January 31, 2021.

Sec. 7. This ordinance shall be operative upon publication, pursuant to Charter Section 252(g).

Sec. 8. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

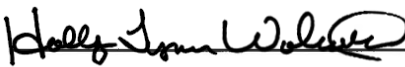
