ORDINANCE NO. 187465

An ordinance amending Schedule "B" of Section 4.900.1 of the Los Angeles Administrative Code to update the salary of a non-represented class employed by the Department of Water and Power to conform to the Los Angeles Minimum Wage Ordinance (Ordinance No. 184320).

THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:

Section 1. The following class position in Schedule "B" of Section 4.900.1 of the Los Angeles Administrative Code is amended as follows:

<u>Class Code</u>	<u>Class Title</u>	<u>Salary Range, Amount, MOU No, or Ordinance No.</u>
3111-1	Occupational Trainee I	1604

Sec. 2. Section 1 shall be operative July 1, 2022.

Sec. 3. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


