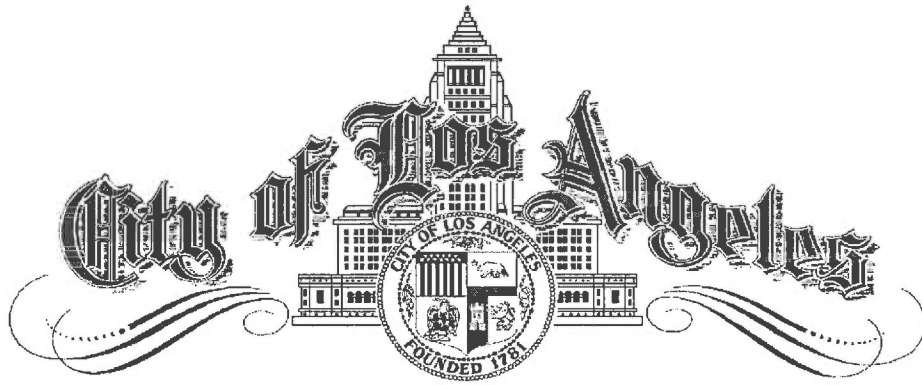

**DRAFT ORDINANCE AMENDING CHAPTER 68 OF THE LOS ANGELES
ADMINISTRATIVE CODE TO RETITLE AND UPDATE THE SPECIAL TRUST FUND
FOR THE CITY'S SIDEWALK AND PARK VENDING PROGRAM AND TO AMEND
LOS ANGELES MUNICIPAL CODE SECTION 42.13 TO RETITLE THE CITY'S
VENDING PROGRAM AND SPECIFY THE GRADUATED PERMIT FEE AMOUNT**

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance amends Section 42.13 of the Los Angeles Municipal Code to retitle the vending program from "Sidewalk Vending Program" to "Sidewalk and Park Vending Program" and specify a vendor permit fee of \$291 until July 1, 2020, increasing to \$541 on and after July 1, 2020.

The draft ordinance also amends Chapter 68 of the Los Angeles Administrative Code to retitle the trust fund and update the City's administration of the fund to reflect the current requirements of the Sidewalk and Park Vending Program. Revenue from vending permit fees and fines collected from vending violations will be deposited in the Fund. The draft ordinance describes the purposes of the Fund and administrative details.

The draft ordinance also includes an urgency clause in order to provide vendors with operating permits as soon as possible.

Fee Notice Requirement

We note that because this draft ordinance would establish a new fee, notice of its proposed adoption should be given in accordance with the provisions of California Government Code Sections 66018 and 6062a. Those sections of State law require that, prior to adoption of a new or increased fee, a public hearing be held and notice of that hearing be published in a newspaper with two publications at least five days apart over a ten-day period. The notice period begins the first day of publication, and there must be at least five days intervening between the first and the second publications, not counting the dates of publication.

Council Rule 38 Referral

A copy of the draft ordinance was sent, pursuant to Council Rule 38, to the Board of Public Works, Board of Recreation and Parks Commissioners, the Economic and Workforce Development Department, the Chief Legislative Analyst and the Chief Administrative Officer with a request that all comments, if any, be presented directly to the City Council when this matter is considered.
