SUBJECT: Council File 19-0688

Pursuant to Los Angeles Administrative Code 2.7.5, transmitted herewith for your consideration are all supporting documents related to denying an appeal of Level I Coastal Development Permit (CDP) No. 18-25 for APM Terminals Landside Infrastructure to Operate Battery-Electric Powered Equipment at Pier 400. A public hearing was held on March 21, 2019, on the question of whether or not the CDP was issued consistent with the certified Master Plan and the California Coastal Act (Master Plan §6.7.3). The appeal was denied by the Board of Harbor Commissioners following deliberation at the June 20, 2019, hearing.
