You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a Public Hearing **telephonically** during a Special Meeting on **Tuesday, November 30, 2021**, at approximately **2:00 p.m.**, or soon thereafter, to consider the following: Exemption from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Sections 15378 and 15061(b)(3), Negative Declaration, No. ENV-2020-5812-ND, and related CEQA findings; report from the City Attorney and draft Ordinance amending Section 12.03 and adding Section 11.5.15 to Article 1.5 of Chapter I of the Los Angeles Municipal Code (LAMC) to define and prohibit Private Detention Centers and Community Detention Facilities for Unaccompanied Minors; and, a report from the Department of City Planning, dated September 8, 2021, relative to the definition of Private Detention Center.

The Los Angeles City Council will also hold a Public Hearing relative to the Ordinance amending Section 12.03 and adding Section 11.5.15 to Article 1.5 of Chapter I of the LAMC to define and prohibit Private Detention Centers and Community Detention Facilities for Unaccompanied Minors, including the Exemption from CEQA pursuant to CEQA Guidelines, Sections 15378 and 15061(b)(3), Negative Declaration, No. ENV-2020-5812-ND, and related CEQA findings. This Public Hearing will be held on **Wednesday, December 1, 2021**, at approximately **10:00 a.m.**, or as soon thereafter as the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012.

Note: If you challenge this proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Clerk at, or prior to, the public hearing. Any written correspondence delivered to the City Clerk before the City Council's final action on a matter will become a part of the administrative record. The time in which you may seek judicial review of any final action by the City Council is limited by California Code of Civil Procedure Section 1094.6 which provides that an action pursuant to Code of Civil Procedure Section 1094.5 challenging the Council's action must be filed no later than the 90th day following the date on which the Council action becomes final.
