

ORDINANCE NO. 188668

AMENDMENT TO MAP 1 AND ORDINANCE MAP OF
THE OLYMPIA SIGN DISTRICT

An ordinance amending Map 1 (Sign District Map) and the Ordinance Map of The Olympia Sign District (District) pursuant to the provisions of Section 13.11 of the Los Angeles Municipal Code (LAMC).

WHEREAS, an amendment to the previously approved District is necessary to correct the Sign District Map and the Ordinance Map;

WHEREAS, the Sign District Map and the Ordinance Map for the previously approved District both erroneously include a small parcel of land zoned R-4; and

WHEREAS, this amendment corrects the Sign District Map and the Ordinance Map for the District to no longer include that small parcel of land zoned R-4.

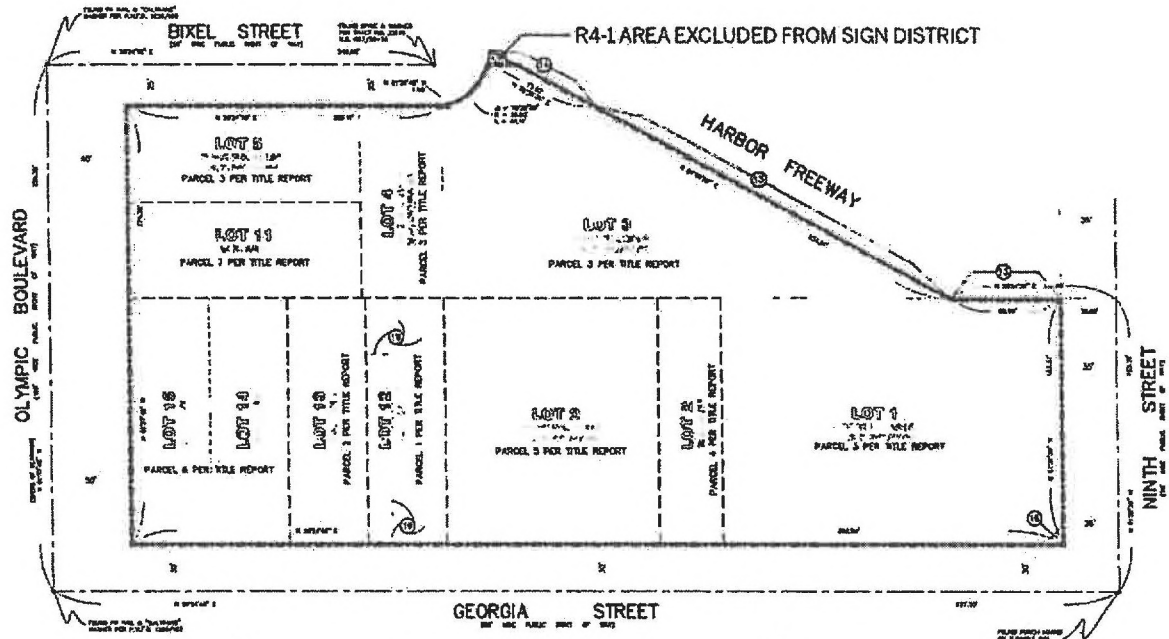
Section 1. AMENDMENT OF THE OLYMPIA SIGN DISTRICT.

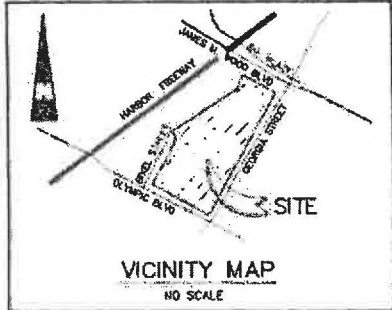
Map 1

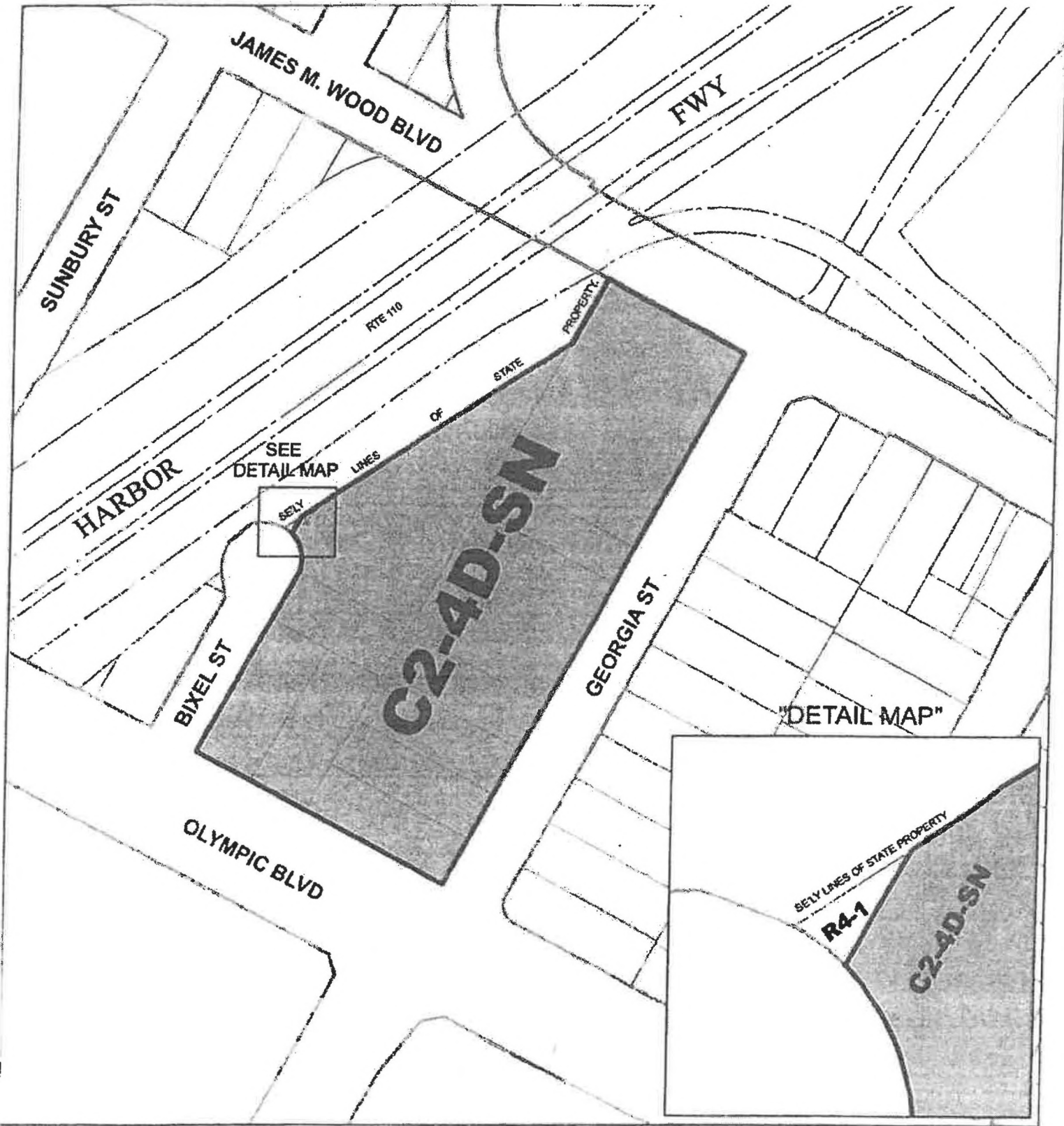


KEY


