SUMMARY

The Los Angeles Fire Department Foundation has donated to the Community Liaison Office one (1) SnapStream Pro (6 channel) tuner and twelve (12) months of SnapStream Pro monthly service. The CLO Section uses the SnapStream equipment to capture media broadcasts relating to the LAFD for training, archival and public dissemination purposes. The previous SnapStream hardware was well-beyond its service life and was used by CLO personnel until it was no longer functional, which mandated the need for updated equipment.

RECOMMENDATIONS

That the Board:

1. Receive this report for the In-Kind Donation by Los Angeles Fire Department Foundation for the items listed above, valued at \$14,980.00 to the Los Angeles Fire Department.
2. Request the Commission Executive Assistant to transmit this report to the Mayor's Office in accordance with Executive Directive No. 3 and to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4 , for consideration and approval.

FISCAL IMPACT

There is no fiscal impact to the Department's budget from the acceptance of this donation. Donations provide the necessary items meeting the needs of the respective fire stations or administration sections. Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.
