## SUMMARY

Mr. Steve Needleman has generously donated to the Los Angeles Fire Department a series of tickets to NBA and NHL games held at Staples Center. Mr. Needleman provides this in-kind donation as a gesture of appreciation to the employees of the Department for their service to the City of Los Angeles. The tickets are subsequently distributed to sworn and civilian LAFD members who participate in a randomized computer-generated lottery. Mr. Needleman has donated 16 ticket packages that each contain four (4) tickets and one (1) premium parking pass. The total value of the donation is \$21,430.00.
