Subject: RESOLUTION NO. 20-9724 – PROPOSED FIRST AMENDMENT AGREEMENT NO. 20-3680-A BETWEEN THE CITY OF LOS ANGELES AND DHS CONSULTING LLC, AN ANSER ADVISORY COMPANY FOR ON-CALL CONSTRUCTION MANAGEMENT SERVICES

Pursuant to Section 373 of the City Charter, enclosed for your approval is Resolution No. 20-9724 authorizing proposed First Amendment Agreement No. 20-3680-A between the City of Los Angeles and DHS Consulting LLC, An Anser Advisory Company; which was approved at the November 19, 2020 meeting of the Board of Harbor Commissioners. The proposed First Amendment Agreement No. 20-3680-A is being requested to change the name of the Consultant from DHS Consulting LLC, An Anser Advisory Company to Anser Advisory Management, LLC. DHS Consulting LLC, An Anser Advisory Company was consolidated under Anser Advisory Management, LLC effective January 3, 2020. There is no impact to the General Fund.

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2(f) of the Los Angeles City CEQA Guidelines;
2. APPROVE Harbor Department Resolution No. 20-9724 authorizing proposed First Amendment Agreement No. 20-3680-A between the City of Los Angeles and DHS Consulting LLC, An Anser Advisory Company; and
3. Return to the Board of Harbor Commissioners for further processing.
