These unknown individuals then opened fire on Mr. Pledger, striking him 16 times and fatally wounding him. Detectives are continuing to investigate this crime but have not been able to identify any leads. The detectives believe a reward may compel member of the public to provide information on the persons responsible for this crime. The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles; therefore, it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of the person or persons responsible for this crime.
