

Ordinance No. 186861
An ordinance amending Subsection (b) of Section 22.210.2 of Article 4, Chapter 10 of the Los Angeles Administrative Code to update the Schedule of Charges for Emergency Services to increase Basic Life Support and Advanced Life Support fees.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subsection (b) of Section 22.210.2 of Article 4, Chapter 10, Division 22 of the Los Angeles Administrative Code is amended to read as follows:

| Emergency Ambulance Service Rendered By City Personnel | Charges |
|--|------------|
| Basic Life Support Fee, Each Patient | \$1,747.00 |
| Advanced Life Support Fee, Each Patient | \$2,463.00 |
| Mileage One Way – Per Mile | \$ 20.00 |

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
