SUBJECT: RESPONSE TO FY 20-21 2ND FINANCIAL STATUS REPORT COUNCIL

**INSTRUCTION NO. 11 RE: IDLE FUNDS** 

On December 8, 2020, the City Council instructed the CAO to report by January 30, 2021 relative to working with the Controller to draw down balances on all available special funds not controlled by the Proprietary departments for cash flow and close out any special funds without active transactions (C.F. 20-0600-S84).

This Office has identified more than \$50M in idle funds that can be transferred to the Reserve Fund as loans, subject to repayment at a later date after June 30, 2021 based on departmental request. The balances in these funds have not seen expenditure activity for over two years, and many over eight years. After the funds have been transferred, this Office recommends that they be formally escheated as soon as legally permissible and all grant funds be transferred to the Reserve Fund permanently unless and until a documented claim is made on the money (Attachment). Council should request the administering departments to transfer the cash balance in each fund to the Reserve Fund.

To further address the budgetary shortfalls, this Office recommends that the following actions also be taken:

- Disencumber all General Fund encumbrances made prior to June 30, 2019. If absolutely necessary, Departments may request reappropriation of any amount still necessary on a case-by-case basis on or after July 1, 2021.
- Instruct departments to repay all long-term Reserve Fund loans immediately unless insufficient funds are available and, if necessary, present for Council consideration requests to re-authorize those loans on or after July 1, 2021.
