They will also feel the weight of loss of officers and longer times because several of the scenes neither will go into prior to law enforcement clearing the scenes. What if that was your family waiting on that officer? I know for my family I want someone there quickly and with less officers that's not possible. With a city this large and the crime stats that we have we can't cut our budget. I understand we are living in a world of cancel culture but the true fact is crime will continue. People will do awful things to people. Loved ones will hurt each other and people will steal. This is the society we live in. Can things change in the department? Absolutely. Is public safety the main thing that should be on everyone's mind? It should be and we can't be safe in a world where citizens are killing each other, robbing people of their possessions and hurting each other. It's a fact. Till society changes we can't live in a world where there are no police. Cutting LAPDs funding will have repercussions and as crime continues to rise we will see that. I just ask that you consider the wait times that will be double, the families that have to wait those extra 15 mins. Some of these calls are life and death. Some don't have 15 mins to wait. See the families that the officers deal with daily. See the people they are helping and see the danger they are in. Just this year we had 2 deputies ambushed for absolutely no reason. These officers are mothers, husbands brothers, children. Grandparents, siblings and more. All we want is everyone to come home safe at night. I appreciate your time. Thank you.

I am writing to express my absolute disapproval and outrage regarding the budget report and recommendations from the City Administrative Officer. The mere idea of laying off 951 sworn officers is unfathomable, especially in light of the rising crime rates in our city. As it stands, Los Angeles has approximately 1 officer for every 433 residents. This places Los Angeles among lowest ratios of police officers to residents of any major city in the United States. If anything, this city needs to INCREASE the number of officers on our streets and we must take crime suppression more seriously.

This year crime in Los Angeles has skyrocketed. According to the latest crime statistics, homicides are up 29.3% this year, shootings up 32.4% and arrests down 25.8%. All of these trends are frightening and are continuing to increase at staggering rates...clearly a result of the massive cuts the LAPD has already sustained. Reducing numbers of officers and specialized units is not the answer. This city is clearly headed in the wrong direction and it is simply unconscionable to even consider cutting funding to those who are tasked with protecting our families, our homes and our businesses.
