As a citizen and homeowner in Los Angeles, I was shocked to get this e-mail from the Los Angeles Police Foundation.

Earlier today, the City Administrative Officer for the City of Los Angeles released a report that recommends a reduction of approximately \$52 million from the LAPD's budget – IN ADDITION TO the \$150 million cut the Department took earlier this year.

The report recommends accomplishing this by laying off 596 sworn positions and 455 civilian positions. The impact of this would be *CATASTROPHIC* to public safety in Los Angeles.

These layoffs would have the following impact:

- Reduce the Department's numbers to a level not seen since the early 2000s, despite having an approximate 67 percent increase in calls for service during that time.
- Force the closure of LAPD divisions, which would impact all aspects of community law enforcement services provided at the division level.
- Increase response times.
- Reduce patrol resources.
- Eliminate specialized enforcement for human trafficking, A Bridge Home, and traffic patrols.
- Impact the LAPD's ability to effectively address Part 1 crimes, particularly at a time when the City is experiencing a drastic rise in homicide rates and shootings. **Homicides to date have exceeded 300 – a number not seen in more than a decade.**
- Reducing civilian personnel will significantly impact public safety services, including:
 - Reporting services to the public
 - Crime scene processing
 - Conducting DNA analysis
 - Fleet vehicle maintenance and repair services
 - Requiring sworn personnel to be moved from patrol to handle civilian functions
