On November 3, 2021, at a properly noticed Special Meeting of the Greater Wilshire Neighborhood Council (GWNC), the Board adopted the following resolution by a vote of 12 in favor, with none opposed and one member abstaining:

WHEREAS, throughout the current and ongoing 2021 City of Los Angeles redistricting effort, the GWNC has again asked the current Los Angeles City Council Redistricting Commission (the Commission) to keep the Greater Wilshire Neighborhood Council intact and whole within one City Council District: and

WHEREAS, the Commission listened and responded to the GWNC request by placing the GWNC intact in Council District 5, with its communities of interest neighbors to the west, but in its final deliberations removed two portions of the GWNC and assigned them to Council District 13 in its final map K2.5, in order to balance the populations of all City Council Districts in the manner required by redistricting law; and

WHEREAS, the GWNC is disappointed that the Commission did not place the entire GWNC in one Council District, and at the same time the GWNC wishes to recognize and honor the exhaustive, unprecedented transparent work of the Commission; and

WHEREAS, the Los Angeles City Council now must review and act on the final redistricting map by December 31, 2021,

The eastern boundary of the GWNC is the middle of the alleyway between Manhattan Place and Western Avenue, or where no alleyway exists, the rear property line of properties along the western side of Western Avenue. The effect is that properties along both sides of Manhattan Place are in the GWNC, and properties along both sides of Western Avenue are in the Wilshire Center Koreatown Neighborhood Council. Here is the boundary description of the GWNC eastern boundary, as taken from the City-approved GWNC Bylaws: ARTICLE III BOUNDARIES, Section 1: (eastern boundary text only) ...Go east on Melrose Avenue until the western property line of the properties on the west side of Western Avenue. Go south along the western property lines of the properties on the west side of Western Avenue until 6th Street. Go west on 6th Street until Wilton Place. Go south on Wilton Place to 7th Street. Go east on 7th Street until the western property line of the properties on the west side of Western Avenue. Go south along the western property lines of the properties on the west side of Western Avenue until Olympic Boulevard... From the GWNC By laws: A OAKWOOD-MAPLEWOOD-ST. ANDREWS NEIGHBORHOOD – Wilton Place from Beverly Boulevard north to Melrose Avenue; east to Manhattan Place (both sides); south to Beverly Boulevard; west to Wilton Place. RIDGEWOOD -WILTON - ST. ANDREWS SQUARE – Wilton Place (both sides) from Third Street north to Second Street; north along Wilton Drive (both sides) and Ridgewood Place (both sides) to Beverly Boulevard; east to Manhattan Place (both sides); south to Third Street; west to Wilton Place.
