**Comments for Public Posting:** The Sherman Oaks Homeowners Association (SOHA) fully supports the Ad Hoc Redistricting Committee's draft Hybrid map as amended through November 9, 2021. The map meets our two overarching redistricting requirements: (1) Keeping the entire Sherman Oaks community, including POSO (Part of Sherman Oaks), whole in a single district; and (2) Giving the Valley its fair share of districts – five full districts and a single bridge district with at least a 68 percent Valley-majority population. The map also reconnects Sherman Oaks to our adjacent Communities of Interest. The November 9th draft Hybrid map has the entire Sherman Oaks community in CD4 which is a single 69 percent Valley-majority district. SOHA knows the Council will be adjusting the map based on public comments from the two state-mandated public hearings. SOHA will continue to support the Hybrid map IF the map continues to meet both our requirements. Thank you.
