I am on the Neighborhood Council of Westchester/Playa Director for District 11 in Los Angles City Council District 11. This area encompasses the residential neighborhood of LA City Ladera south to the 405 Freeway. Our area is known as the east Westchester community. On behalf of our residents we want to oppose the K2 Map plan to move our community out of Westchester into CD 8.

In the 10 years since our community was redistricted into CD 11 we have developed strong bonds with the Westchester. We share churches, shopping and business centers with Westchester. We have community signs in our business district that say 'Westchester', we have a seat on the Neighborhood Council, we work with LAPD's Pacific Division Community Policing Unit, Councilman Bonin sponsors our neighborhood Block Party, we participated in the Westchester Santa Claus Holiday Caravan, and with the support of the Neighborhood Council and our Councilman our neighborhood got it's official name of 'Ladera' after 70 years.

Until the previous Los Angeles City Council Redistricting Commission moved us into Council District 11 our neighborhood had been forgotten for decades by most of Los Angeles City Departments. We had major public safety hazards and issues with other city services, but our area is so small and removed from CD 8 that we were ignored, and our voices were not heard. We had street signs that were 35 years old with letters missing making it difficult for first responders to find us in emergency situations, frequent power outages, dangerous intersections and trash that were frequently not picked up. Since we became part of CD 11, our community had been recognized. We had a community meeting with Councilman Bonin and superintendents from several city departments and they heard how poor the service was and we finally got improvements. DWP came to service our power poles for the first time in 10 years, the city made new street signs for the neighborhood, Bradley Place got resurfaced for the first time in 30 years, intersections with blind spots got red curbs painted, two of the most dangerous intersections got stop signs, the Councilman's office helped on community clean-up, and they helped get funding for a major relandscaping and storm water reclamation project on La Cienega (the gateway to LAX) in our community.

Under Los Angeles Council District 11 our neighborhood has been improving. We now have a seat on the Neighborhood Council of Westchester/Playa and we share the same issues with the rest of the Westchester community about our parks, homelessness, airport noises, etc. With the purposed plan in Map K2.5 we will lose our Neighborhood Council Residential Districts seat and our ability to have the voices of our residents heard at City Hall. Map K2.5 will take away our hope for further improvements.

The Neighborhood Council of Westchester/Playa (NCWP), representing the various stakeholders who live, work, and play in the Westchester, Playa del Rey and Playa Vista communities are oppose the transfer of Residential District 11 (Ladera) into Council District 8 (CD8). We are asking the 2021 Redistricting Commission to keep Residential District 11, the area named Ladera/Triangle within boundaries in Council District 11 (CD11). The boundary of Ladera starts with an 'L' shape on the north between 62nd and 63rd Streets, extending from three blocks west of La Cienega Blvd. to La Brea, and south on La Cienega into the Triangle area south of Centinela Ave. to east of the 405 Fwy. The area has become an integral part of our community and has strong ties to Westchester/Playa.

Residents in this area share common interests with the rest of Westchester. Their children play Little League in Westchester, and many go to school in CD11. We share shopping and business centers, churches, police and fire stations, property values, and income levels. We also share common community concerns such as airport noise and traffic. One of the neighbors has received numerous accolades for her work and leadership on the Ballona Creek Art Project.

We are geographically connected to CD11, because of the way the City of Los Angeles created the connection to the Los Angeles International Airport. Ladera was the City's original "Gateway to LAX" connecting the city to its airport between LA County and Inglewood in the 1940s. LAX is still one of the main interests our residents have in common with the rest of Westchester. Many of our residents either work or have retired from the airport. We share concerns for airport noise and travelers parking in our neighborhood to catch an Uber to their flights. We also share concerns about airport traffic. The main thoroughfare for the new LAX Consolidated Rent-A-Car (ConRAC) facility runs through our community. When this facility opens and the traffic doubles on La Cienega, our residents need to be in CD11 to have a voice heard on this important matter.

We are unified in our desire to keep Ladera and the triangle area in Westchester where they have forged strong bonds within the community and have finally gained a real voice in city government through the Neighborhood Council of Westchester/Playa. This neighborhood has been shuffled around by City Redistricting Commissions for the last 30 years. They were formerly in CD10 and then moved to CD8. The Commission did not recognize that Ladera is a diverse community of 309 households with common interests on the westside of Los Angeles.


In the last Redistricting in 2011, Ladera finally moved to CD11 where the community has flourished. Westchester welcomed Ladera and gave the area a seat on the Neighborhood Council. With the help of the NCWP and our

Councilman, this community was empowered to resolve numerous decades-old problems with city services and public safety.

The connection with Westchester and the NCWP has attracted new business Residential District 11. The former rundown commercial center was revitalized and new businesses including Amazon Fresh, Spectrum, and Marshall's. These stores identify and brand themselves as Westchester locations. These new businesses based their decisions to invest in this community on the on criteria such as incomes and educations levels of residents in Westchester. It is a betrayal of the City's commitment to these businesses and our residents to move this community into South Los Angeles CD8.

If Redistricting Map K2.5 is adopted without restoring this community to CD11, the Neighborhood Council of Westchester/Playa will lose a District Director seat, which represents the community stakeholders that will be impacted by the ConRAC and LAX Modernization Project. Also, the Ladera/Triangle area is part of the Westchester - Playa del Rey (WPDR) Community Plan, the development of this is predicated on the area being integral part of the CD11.

By being part of Westchester, this long forgotten neighborhood received improvements including having streets repaved for the first time in 30 years, LADWP conducted an inspection and repaired power poles for the first time in 10 years resolving frequent power outages, and stop signs were installed at dangerous intersections where there had been multiple accidents, and our trash is now picked up regularly. Most importantly when one of the Ladera neighbors died because the paramedics went to the wrong street as a result of the 35-year-old street signs missing letters, the NCWP got the city to create custom street signs for the neighborhood with the city seal so no first responders would ever make that mistake again. The residents in Ladera/Tringle want their community to continue moving forward not backward by keeping it in Council District 11.
