#### ORDINANCE NO. 187279

An ordinance amending Sections 2.23, 2.24, 2.25 and 2.26 of the Los Angeles Administrative Code to establish new Council districts for the City of Los Angeles as provided in Charter Section 204.

# THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 2.23 of the Los Angeles Administrative Code is amended to replace the metes and bounds descriptions of the 15 City Council districts with the metes and bounds descriptions contained in Attachment A1 to this ordinance. Attachment A1 is incorporated by reference and made part of this ordinance with the same force and effect as if set forth fully herein.

Sec. 2. Section 2.24 of the Los Angeles Administrative Code is amended to read as follows:

The boundary line of the City of Los Angeles, as referred to in this Article, shall be the same as existed on December 1, 2021.

Sec. 3. Section 2.25 of the Los Angeles Administrative Code is amended to read as follows:

The Census Tracts and Blocks, as referred to in this Article, shall be those delineated on the United States Census Bureau's Topographically Integrated Geographic Encoding and Referencing (TIGER) files as approved by the United States Census Bureau for use in the 2020 Census.

Sec. 4. Section 2.26 of the Los Angeles Administrative Code is amended to replace the term "2012 ordinance" with the term "2021 ordinance."

Sec. 5. The provisions of this ordinance shall become effective upon publication in conformance with Los Angeles City Charter Section 252(h).
