The reason for this being that the San Pedro Chamber of Commerce President/CEO Elise Swanson did state on 10/28/20 in public comment for the project [2111-2139 South Pacific Avenue](#), “that these types of projects are critical”. Many of us agree but not with something that is so out of scale at this location being so large. But more importantly the Chamber President Elise Swanson has also supported the project at [1309-1331 South Pacific Ave.](#), also by the same developer, but it has NO--Ground Floor Retail, which always has been critical in all our commercial designs for years. So there appears to be conflict here. Where is the Ground Floor Retail for the [1309-1331 South Pacific Avenue](#) proposed project?

The Chamber President also said of how they worked so closely with the developer for a great parking plan. This is not realistic how the city can approve such projects with not adequate parking. It is totally ridiculous.

I also would like to hear from the city about the street widening on 22nd Street for the busses, and would like to see this on the plans. Street widening on 14th Street for the egress of cars into the new project.

I also would like to hear from the city for the relocation within San Pedro of the existing trees at both location sites, and not about any destruction of these trees.

I would also like to hear from the city of how the South Pacific Avenue Tsunami escape corridor is being considered and protected.
