- Semi-Trucks full of fresh produce distributed to the community
- Endless amounts of hygienic products distributed
- Several tons of fresh fruit and vegetables delivered to the homes of the community.
- Various social, academic and athletic resources provided over video, phone and social media
- Partnerships developed to connect locals that desire mental and sociological support

SUMMER 2020 OBJECTIVE

When violence traditionally sees an uptick during these summer months in urban communities, we want to make sure that the community has access to safe recreational, educational and mental resources during COVID-19 and beyond. This will be accomplished by adapting site-based programming to a new virtual/hybrid model that meets the needs of the Watts community.

THE NEED

COVID-19

Los Angeles County has five of the 10 most crowded ZIP Codes in the United States, and public health officials said such housing conditions can accelerate the spread of the virus. A majority of those we serve in Watts live in a close proximity to each other, which makes social distancing more complex. In a recent study, officials have found that African Americans are dying at the highest rate in the county. The death rate for African Americans is 13.2 per 100,000 people, compared with 9.8 for Latinos, 7.9 for Asians and 5.7 for whites.

HEALTH CARE / ACCESS TO HEALTHY FOOD

Urban communities are being disproportionately impacted due to their poor health conditions, access to quality health care and often living in a "food desert" with minimal access to healthy food. The consequences are also clear: decreased access to healthy food means people in low-income communities suffer more from diet-related diseases like obesity and diabetes than those in higher- income neighborhoods with easy access to




















SUMMER MONTHS

Higher temperatures, longer daylight hours, and more foot traffic create an increase in interaction and irritability between people. This then provides more opportunity for crime. Although studies are not conclusive enough to show how exactly warmer temperatures cause an increase in crime, researchers still agree that there is a correlation: When temperatures rise, so do property crimes.

384 larger law enforcement agencies reported to the FBI that, on average, monthly crime for seven major offense types increased nearly 10 percent between June and August from the rest of the year. Teenagers and children, in particular, lack activities to structure their time while out of school.

THE PLAN

VIRTUAL CAMP

In partnership with The Harold Robinson Foundation (HRF) we are bringing camp to our youth. HRF has established itself as a leading community program in the Watts community for over 12 years. Building on the success of Camp Ubuntu Watts (CUW), HRF has launched CUW 2.0 to continue supporting the social emotional development of our students during this global crisis. The virtual experience will be implemented via the zoom platform and will allow for high energy, creative interactive programming.

Camp begins June 8th and runs for 4 weeks Monday – Friday! More info below in Programming & Partnerships.

VIRTUAL SPORTS

We are continuing to provide ways youth can get training and stay active even if they aren't around large groups. One such example we provide this is through social media platforms with our partner, Street Soccer USA, providing soccer clinics Wednesdays and Fridays every week online!















Chromebook Laptops we helped deliver to many of the youth in Watts thanks to the generosity of the Housing Authority of the City of Los Angeles. During the school year, most schools provided online support, but we are wanting to further meet educational needs even during the summer. We are teaming up with 2K Foundation that is developing further educational resources and an APP. We are desiring to acquire Tablets/iPads so we can more easily meet the needs of the local community during these COVID-19 times.

OUTDOOR BASKETBALL AND SOCCER COURTS

We have been told not only by locals but on numerous occasions, "Your futsal (soccer) court is top of the line." "Your basketball court is one of the coolest outdoor courts I've seen anywhere." We are grateful to Adidas, Los Angeles Football Club and the U.S. Soccer Foundation for building our outdoor futsal/soccer court and basketball courts. The locals take great pride in them. We desire to provide recreational activities on both courts, both organized and pick-up games. Our partnerships with local professional NBA Teams (Clippers, Lakers and LA Sparks), Venice Basketball League, as well as friendships with NBA players like Tony Snell who is from Watts adds an exciting aspect of safe programming that could be enabled. Partnerships with Adidas, LAFC, U.S. Soccer Foundation and Street Soccer USA are but a few of our strong supporters that want to make sure our local youth and teens are given healthy access to sport during this COVID pandemic.

OUTDOOR RECREATIONAL ACTIVITIES

We are grateful that the Watts Empowerment Center has not only this amazing 12,900 sq ft building but also an outdoor Skate Park and field located on 3.3 acres. This land in the heart of Watts is a refuge for the community. The field on the exterior of the building is just getting completed a 2-month installation and fixing of an irrigation system so the kids can play on grass instead of dirt. This will enable us to provide opportunities for youth to be outdoors, in a social distanced manner, while engaging in activities!

INDOOR BASKETBALL COURT

Proudly proclaimed by many locals, "The best court in any urban community!" We are honored to have personally developed a court so beautifully thanks to the generosity of (NBA) 2K Foundation. People often describe the Watts Empowerment Center as the heartbeat of the community. Well the basketball gymnasium would definitely be that heart! Our Watts Empowerment League consists of both an Adult League for the Teens and Adults. We also have the Little Legends League for those ages 5-12. We were told it wasn't possible to have people compete













across different territories and divisions. Once again, the community has defied the odds and we have Teams from Watts, Compton, Long Beach, Venice and Wilmington that compete in the Watts Empowerment League. Although we long to re-start the league, we will wait to do such till proper health steps and goals are met in Los Angeles. We simply desire to get basketball accessible to so many of the youth that have trained for so many years and truly are praying for a college scholarship. This time is crucial for many of them going into their senior year.

NUTRITIONAL COOKING CLASSES

We are fortunate to have various chefs and nutritional cooks that come and teach at the Watts Empowerment Center. We have to keep these classes to the size of 5-8 to effectively teach these classes. We recently acquired a commercial stainless-steel fridge as well as a commercial freezer. We are excited about getting to further utilize these with the future "masterpieces" that these locals create in these classes!

YOGA / ANTI-BULLYING WORKSHOPS

The impact of these gatherings when a child/teen is able to simply quiet their heart and mind in a safe setting has been truly powerful. Over and over the individuals that have come to teach these classes are typically high-scale yoga clinics in West Hollywood and Beverly Hills that offer great expertise. The youth are taught that often bullying, screaming and lack of attention often stems out of feeling lack of control or peace in their own life. So, we try to provide some time for them to find peace, know that they are supported/loved, and that they are the victor not the victim. History will be good to them, because they will write it!

ETIQUETTE COURSES AND MOCK JOB INTERVIEWS

Watts is, or is close to, one of the largest neighborhoods in California that is ran by single mothers. Many of the fathers are incarcerated, no longer around, etc. So we are honored that many of the homes are very grateful we teach these Etiquette Courses. It happens based upon demand basis and consists of everything from teaching a person how to shake hands, look at someone in the eyes when speaking, not to interrupt another conversation without requesting, and how to tie a tie. We often have dived deeper for the older youth who want to learn how to prepare for a job, ranging from how to write a resume to how to "dress for success," always being on time (10 minutes early) for a meeting, etc. Although social distanced measures are needing to be implemented, we are looking forward to getting these Etiquette Course and Mock Job Interviews going!















SOCIAL-EMOTIONAL / MENTAL HEALTH / STRESS MANAGEMENT WORKSHOPS

The pressures our youth feel is different and attacking them in ways that prior generations have not had to face. That is why we want to further provide high-quality programming that enables youth to discuss such in a safe and open environment. We believe these pressures and stresses feed into the mental, emotional, physical and educational aspects of their life. It is crucial our youth are not told simply to "be quiet" but rather to empower them how to deal with stress, be resilient, understand how to take personal control of their situations, personal responsibility, as well as understand how their unique identity and purpose is part of a collective narrative they are part of!

COMMUNITY MOVIE NIGHTS

The exterior of the Watts Empowerment Center has a massive 40ft wall on its backside. We would like to host socially distanced CommUNITY Movie Nights. We have already purchased a 40ft screen and a Foundation bought us a \$30k projector so that the locals could experience a "Theater-like Experience" in the middle of Watts! We would like to buy some new grills so some of the fathers can cook for their kids, and of course bring out a load of popcorn! Since we have a massive outdoor basketball court right next to the wall, we can easily allow locals to socially-distance while enjoying these larger than life moments to bring the CommUNITY together!

PROGRAMMING & PARTNERSHIPS

HAROLD ROBINSON FOUNDATION • VIRTUAL CAMP UBUNTO WATTS 2.0

In an effort to continue supporting the social emotional development of our Watts youth, the virtual experience will include activities such as art, yoga, creative writing/expression, and music. In between sessions there will be camper DIY (do it-yourself) projects on the Ubuntu Camper blog. Camp will begin on June 8 and will run for 4 weeks with programming occurring Monday-Friday starting at 12pm and 4pm. Camper kits will be delivered to provide materials needed to support programming activities.

CAMP UBUNTO WATTS • ON-SITE

This will provide a free, 4-6 week summer program at the Watts Empowerment Center. Ubunto means "I AM BECAUSE WE ARE." Camp Ubuntu Watts has successfully partnered with LAUSD for the past 7 years at Markham Middle School. With the closure of schools for the summer, CUW is proud to partner with Watts Empowerment Center to continue providing a creative, fun-filled camp experience. During this pandemic, we want to provide much-needed enrichment directly where our















youth and their families live. This is specifically important during the summer months when crime rates are at their highest and access to resources diminished.

At CUW, we will encourage positive self-development and foster teamwork by offering a holistic and balanced schedule of programming. On any given day, campers engage in something artistic, athletic, and enriching, where high-quality programs range from filmmaking to conflict resolution. Group rotations, while practicing social distancing, introduces students to a variety of activities and a free-choice component.

DOLE • SUNRISE PRODUCE • EVERYTABLE

When the COVID-19 pandemic hit, we were fast to start strategizing ways to meet the various needs of the community. We have developed partnerships over the following weeks to provide weekly food we distribute to the homes of the Elderly and Disabled. This has further grown into battling for the nutritional health needs of the community. We continually are providing semitrucks full of fresh food, produce and clean water that many of the locals are not accustomed to receiving. In this time when so many are financially hurting beyond their normal circumstances, due to COVID-19, we are working around the clock to meet the needs of the community.

CITY OF LOS ANGELES MAYOR'S OFFICE • GRYD • SUMMER NIGHT LIGHTS

The Summer Night Lights program is a public and private partnership undertaken by the City of Los Angeles Mayor's Office of Gang Reduction & Youth Development ("GRYD") and The GRYD Foundation.

Summer Night Lights ("SNL") traditionally operates in 32 locations across the City of Los Angeles, keeping recreation centers and parks open between the hours of 7 pm – 11 pm during the summer and adding extended programming.

Due to COVID-19, adjustments are being made. We eagerly await being informed of this information. SNL expands the menu of activities at each site beyond what is traditionally offered. As a result, community members can participate in free sports, arts and recreational activities, resource fairs, health screenings, workshops, and connections to resources that they can utilize year-round. GRYD programming focuses on areas that have been heavily impacted by gun violence, that lack resources due to socioeconomic disparities, and where many individuals are experiencing the effects of multi-generational poverty and exposure to trauma.

Summer Night Lights, Fall Friday Nights and Youth Squad 360 programming work together to transform lives across Los Angeles.

















STREET SOCCER USA • ADIDAS • LAFC • US SOCCER FOUNDATION

Thanks to the generosity of Adidas, Los Angeles Football Club and the U.S. Soccer Foundation who built our outdoor futsal/soccer court, the community has an amazing partnership! We want to resume our Watts Empowerment Futsal/Soccer Clinics for the youth which happens twice a week providing essential time for the youth to exercise, work on teamwork as well as develop their skill and love of the game. Street Soccer USA facilitates this as well and is ready to do such in a safe manner. We also host the Watts Empowerment Futsal Tournament which is exciting to see youth come from all over Watts and beyond to compete. Since this tends to draw a crowd, we plan on waiting to resume the tournament when the health officials feel such group sizes would be appropriate.

LOS ANGELES UNIFIED SCHOOL DISTRICT (LAUSD) • THE AMERICAN RED CROSS

Partnering with our local educational districts is crucial to us. One way we partner with LAUSD is through feeding programs. Los Angeles Unified, in partnership with the American Red Cross, continues to provide nutritious meals to all students who need them during the closure of schools and beyond. These various 60 Grab & Go Food Centers are staffed weekdays from 8 a.m. to 11 a.m. Each child can take home two nutritious meals. These locations are crucial in providing meals that many of the youth we serve would not have access to otherwise. We partner with LAUSD and American Red Cross to ensure our youth are not only knowledgeable of such opportunity, but also in providing food to the community. It is not uncommon that these locations cannot distribute amongst the community directly all that is needed and ask if we can facilitate providing these healthy meals to those greatest in need. We do simply that! Meeting not only physical health needs, but also understanding what is being taught educationally and being aware of the social, mental and physical challenges the youth undergo is crucial to knowing how we can most effectively impact a child/teenager's life. A parent would like to hope their voice is the "loudest" in their child's life, yet studies show that a teen's peer-circle plays the largest role in their decisions. So, we are very active in understanding a well-rounded approach of the "voices" our youth hear.

CLIPPERS • LAKERS • LA SPARKS • 2K FOUNDATION

The same generosity of the 2K Foundation that is developing further educational resources and renovated the entire indoor basketball court continues! It is wanting to further partner with us to provide summer basketball opportunities for the community. Thanks to them and our relationships with the local professional NBA and WNBA Teams, we simply want the community to have positive outlets to express themselves. In a community that often feels like they are being told "No", we want them to feel there are positive outlets that have said "Yes" to them being able to express their selves in a healthy manner.

Decades of racist policies, land use planning and disinvestment from LA's Black communities continue to have devastating effects today. Black residents continue to experience higher rates of unemployment and are overrepresented in the homeless population. For instance, when i moved to the densely populated, multicultural Vermont/ First St. neighborhood area 9 years ago, very few black people lived here. In the past few years they seem to be the largest number of people living here - UNHOUSED! Black and Latinx communities still face the deepest inequities and are most impacted by eviction and displacement, so we must invest in housing solutions and protect their worker rights and wages. I am asking you to reallocate a enough of the of 2020-2021 LAPD budget to make a significant difference in funding affordable housing, fully fund Right to Counsel and Eviction Defense and fully funded Office of Wage Standards and Day Laborer Centers. The cost of funding these programs is miniscule compared to the \$1.189 billion police operations budget. I believe that, over time, these investment will automatically reduce calls for police intervention and automatically reduce the \$215.000,000 overtime budget. In my opinion, the police could easily reduce \$150 + million just by reducing the number of \$3000 helicopter deployments and reducing the number of military-style weapons. I urge you to re-allocate at least \$150 million from the 2020/2021 budget and begin funding programs that truly help people, instead of criminalize them. Thank you.
