As instructed by the Ad Hoc Covid-19 Recovery And Neighborhood Investment Committee for CF No. 20-0862 at the October 21, 2020, meeting, the Los Angeles Department of Aging (LADOA) is submitting the additional information as requested.

The Committee requested more information on the cost to implement an alternative program model that would provide new eligible senior participants with food boxes of groceries instead of meals. Unfortunately, in speaking about a potential partnership with the Los Angeles Regional Food Bank the department was informed that they were at capacity and will not be able to expand further at the time. We will continue to explore opportunities to increase food access to older adults.

LADOA has identified grant funds to provide grocery delivery for older adults who cannot afford the extra fees associated with deliveries. We have also established a partnership with LA County to assist with grocery deliveries as needed.
