

AUTHORIZING RESOLUTION

A RESOLUTION APPROVING AN AMENDMENT TO THE STANDARD AGREEMENT ISSUED UNDER THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM CORONAVIRUS RESPONSE (CDBG-CV)

BE IT RESOLVED by the *City council of the City of Los Angeles* as follows:

SECTION 1:

The City of Los Angeles has reviewed and hereby approves the submission to the State of California ("State") of a Request for Additional Funds to fill funding gaps created by documented cost increases. The funds would be added to the existing CDBG-CV Standard Agreement(s) with the State numbered 21-CDBG-HK-00020-Best Western NoHo, 21-CDBG-HK-00021-Super 8 Canoga Park, 21-CDGB-HK-00022-Orchid (the "Standard Agreement(s)") pursuant to the State's June 2020 CDBG-CV1 Notice of Funding Availability; December 2020 CDBG-CV2 and CV3 Notice of Funding Availability (NOFA); and/or the CDBG Method of Distribution as described in the State of California 2019-2020 Annual Action Plan August 2020 Second Substantial Amendment and the CDBG-CV Method of Distribution as described in the State of California 2019-2020 Annual Action Plan August 2020 Fifth Substantial Amendment.

The City of Los Angeles previously approved the use of \$9,450,000 for this CDBG-CV activity which was included in the 21-CDBG-HK-00020-Best Western NoHo, 21-CDBG-HK-00021-Super 8 Canoga Park, 21-CDGB-HK-00022-Orchid and, by this resolution, will use an additional amount not-to-exceed \$1,737,500 for a total commitment of \$11,187,500.

SECTION 5:

If an amendment to the Standard Agreement is approved, the City Administrative Officer, or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State from time to time in connection with this grant.
