**Comments for Public Posting:** Good Afternoon, As the Business Representative from the Greater Wilshire Neighborhood Council, I have many concerns about the apparent randomness of who's allowed to apply for 'Al Fresco Dining' as it relates to Larchmont Boulevard. Not every food and beverage establishment should be allowed to apply for outdoor dining. We have a situation where 'Grab and Go' businesses are gobbling up much needed parking spaces in our tiny village, spaces that sit vacant before and after the stores hours, while cars unsafely double park in the median. If the business in question has a proper dining area indoors, then the Al Fresco Dining program should apply to them. With the proliferation of new ice cream shops, pastry shops, coffee shops and high end juice stores on Larchmont, a hand full of benches or tiny tables and chairs on the sidewalks should easily fill the need to nosh, without sacrificing parking for the other types of businesses on the boulevard that are not food related. I also have concerns about the loss of parking meter revenue to the city, which continually seems to have a cash shortage when it comes to repairing sidewalks, trimming trees, and painting curbs. It feels like an old fashioned 'land grab' when businesses can apply to quite literally double the size of the establishment, at the expense of the city.
