RECOMMENDED ACTIONS

1. That the Board REVIEW and APPROVE the above Amendment.

- 2. That the Board request the Mayor and Council to:
 - A. APPROVE the attached Amendment for payment by the Housing Authority of the City of Los Angeles (HACLA) to the Los Angeles Police Department (LAPD) as a part of the Community Safety Partnership (CSP) Program to increase and enhance the safety, security, and welfare of the HACLA residents through the presence and relationships of the LAPD officers deployed and assigned to the eight public housing developments program sites of Ramona Gardens, Nickerson Gardens, Jordan Downs, Imperial Courts, Avalon Gardens, Gonzaque Village, Pueblo del Rio, San Fernando Gardens; and,
 - B. AUTHORIZE the Chief of Police to execute the attached Amendment, on behalf of the City, with the HACLA.
- 3. That the Board TRANSMIT the Amendment concurrently to the Mayor and the City Council for their approval.

DISCUSSION

There exists a need in various public housing sites around the City of Los Angeles to increase "community livability," to help promote the safety, security and welfare of residents of the sites. The HACLA desires to continue a partnership with the LAPD to ensure dedicated, full-time law enforcement resources in eight public housing developments. The Department values and supports the continuation of the CSP program policing model that relies on long-term assignments of police personnel to the program sites.

FISCAL IMPACT STATEMENT

The HACLA will provide the LAPD an additional reimbursement sum up to eight hundred seventy- five thousand dollars (\$875,000.00) to continue to operate the CSP Program during the extension period of July 1, 2020 through December 31, 2020. The total reimbursement sum under the Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, and Amendment No. 4 shall not exceed eight million, nine hundred fifty-seven thousand dollars (\$8,957,000).

Attached for your review and signature are two originals of the Amendment No. 4 Memorandum of Agreement (MOA) between the Housing Authority of the City of Los Angeles (HACLA) and the Los Angeles Police Department (LAPD). The HACLA desires to continue a partnership with the LAPD to ensure dedicated, full-time law enforcement resources in eight public housing developments. The LAPD desires to continue the Community Safety Partnership (CSP) Program policing model that relies on long-term assignments of police personnel to the program sites. The HACLA will provide the LAPD an additional reimbursement sum up to eight hundred seventy-five thousand dollars (\$875,000.00) to continue to operate the CSP Program during the extension period of July 1, 2020 through December 31, 2020. The total reimbursement sum under the Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, and Amendment No. 4 shall not exceed eight million, nine hundred fifty-seven thousand dollars (\$8,957,000).

The Office of the Los Angeles City Attorney did not review the Amendment on behalf of the Department because the purpose is only to provide the LAPD an additional reimbursement sum to continue to operate the CSP.

The Amendment was reviewed and approved by Commander Gerald Woodyard, Community Engagement Group; and, Management Analyst Allison Ogtong, Fiscal Group.

WHEREAS, on or about November 1, 2019, the Parties entered into Amendment No. 2 of the Agreement ("Amendment No. 2") to expand the CSP Program to an eighth (8th) public housing site, the San Fernando Gardens public housing development, and to increase the maximum allowable reimbursement amount under the Agreement for the deployment of officers to the additional CSP Program site; and

WHEREAS, on or about May 12, 2020, the Parties entered into Amendment No. 3 of the Agreement ("Amendment No. 3") to extend the term of the existing Agreement by six months to June 30, 2020 to allow for additional time to negotiate a new five-year agreement; and

WHEREAS, the CSP Program is a policing model that relies on long-term assignment of police personnel to develop relationship-based policing by working with a variety of community stakeholders to help promote the safety, security, and welfare of residents of public housing developments and the surrounding communities; and

NOW, THEREFORE, it is mutually understood and agreed by HACLA and LAPD to amend the Agreement as follows:

- 1. Section 2, "Term," is hereby amended to reflect that the Agreement Term is extended six (6) months and shall terminate on December 31, 2020.
- 2. Section 3, "Funding" is hereby amended to reflect that HACLA will provide LAPD an additional reimbursement sums up to Eight Hundred Seventy-Five Thousand Dollars (\$875,000.00) to continue to operate the CSP Program during the extension period of July 1, 2020 through December 31, 2020. The total reimbursement sum under the Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, and Amendment No. 4 shall not exceed Eight Million, Nine Hundred Fifty-Seven Thousand Dollars (\$8,957,000.00).
- 3. The Parties mutually agree that this Amendment No. 4 is incorporated in the Agreement for all purposes and all terms and conditions of the Agreement shall remain in full force and effect except as expressly amended by this Amendment No. 4.
