My clients are exhausted, under-served, and on the brink--they don't need to be criminalized for having nowhere to go. The services promised with sweeps often don't come, or don't work. It's salt in a wound: Project Roomkey is phasing out, at my last count 6 shelters in SPA 4 alone were on covid quarantine, it can take weeks to get from an access center into a bed, and the eviction moratorium has ended, meaning resources are about to get even more scarce as more people enter homelessness. We have enough on our plates as it is. People's most important belongings, like ID and medication, are routinely trashed during these sweeps, even though they're not supposed to be, leaving frontline providers to pick up the pieces and clients newly demoralized. I don't agree with the current implementation plan, but even the few protections included in it are not being enforced correctly. We don't need any more fear and disruption in our clients' lives, and 41.18 expansion practically guarantees it.

**Comments for Public Posting:** My name is Amy Tannenbaum and I am a staff attorney in the Lawyers Preventing and Ending Homelessness Project at Public Counsel. On behalf of Public Counsel, I urge this Council to vote NO on the amendment to 41.18. This dramatic expansion of 41.18 enforcement zones would enact cruelty on unhoused Angelenos, making them more susceptible to criminalization, barriers to housing, and death. 41.18 on its face is inhumane: its goal is to remove unhoused people from public sight, without any regard for their well-being or any plan for addressing the root causes of homelessness. These particular expansions will affect a broad swath of the city, and their impacts have not been adequately studied by the council. As a legal services attorney, I work closely with unhoused clients to remove barriers to housing. This work is funded by taxpayers throughout LA county, including in the city. We meet clients who cannot get a job or an apartment due to their criminal record or due to unpaid tickets on their record. Having to go to court for citations also makes it difficult to hold down a job and stay stable, and unpaid tickets can lead to poor credit scores and being locked out of future opportunities for employment and housing. So in addition to being cruel, 41.18 is also inefficient: it is irrational for the city to criminalize the very fact of being unhoused, allowing widespread ticketing and arrest of unhoused Angelenos that will make it harder for them to get a job and an apartment, and turn around and expect those same clients to rely on city- and county-funded services to unravel the collateral consequences of criminalization. The better solution would be to avoid criminalization outright and instead invest in affordable housing and services that make it easier – not harder – for unhoused Angelenos to get and keep housing. I ask that the council vote NO on this amendment to 41.18 and to instead enact compassionate and human responses to help, not criminalize, our unhoused neighbors.

As you know, there are not nearly enough shelter beds, and as a service provider, I am very familiar with how long the process takes for the relatively few and lucky individuals who are able to obtain a housing voucher. This measure will lead to more displacement of unhoused people, making it that much more difficult for service providers like me to locate them during the crucial, time sensitive periods in which meetings with the Housing Authority and other entities are required to secure permanent housing. It will also lead to more unhoused individuals' shelter being taken and destroyed, leaving more people vulnerable to the potentially deadly summer heat. This will also prevent people from being able to effectively self-isolate, thus making them more susceptible to contracting and spreading COVID-19, which as we know has been steadily climbing. I understand wanting to protect parents and children from the more unstable individuals, but the 500ft ban is extremely excessive, and will lead to massive confusion about where is and is not safe to sleep. Homeless services in this city is already so fractured and disorganized, please do not make my job harder, but mostly do not wreck further havoc on the most vulnerable citizens of our city.

At this point, the 41.18 policy has shown to have only harmed unhoused populations and done nothing to lead to stable, regular shelter. Expanding this zone to reach 20%+ of the city is an even more dangerous proposition. This happens as the city prepares to push even more residents to the streets: eviction protections are declining, Project Roomkey is ending, and little has been done to create any alternatives or stable, supporting or social housing. On top of this, we are seeing yet another COVID-19 surge that sweeps are known by the CDC to worsen. This reckless move is happening with no real map of where zones will be created and no transparency as to what/how this will play out. In fact, it is only thanks to volunteers that we know that this policy will reach nearly 1/5 of our city - a massive swath of places where people are surviving. In treating schools and daycares centers as targets for sweeps, we also ignore the fact that children and youth are a large portion of the unhoused; it is a proposition based on some (likely racist and anti-poor) fantasy that those on the streets are some danger to our young people, not students, families, residents, and human beings themselves who have been affected by the massive inequality that now defines like in LA. The Council has the chance to reverse course, to not become known for a relentless assault on vulnerable and poor Angelenos. It can instead the millions needed to maintain these sweeps to actual supportive housing and support, instead of the wholesale violence, abuse, destruction of property, exclusion, and for some, yes - death - that sweeps bring. I have lived here in my whole life, growing up in CD9, moving to CD13 and now in CD1. One thing connects this whole city and it is a diverse and vibrant community that - at its grassroots - can be defined by shared humanity and collective support. We saw this in all the efforts for mutual aid and care, and the movements like immigrant rights and for Black Lives. Now the City Council has a chance to honor this by moving away from its march to criminalization and actually invest to support its residents, its young people and elders, and move instead to invest in supportive, social and affordable housing and care.

For previous amendments, every address of a 41.18 zone was listed, reviewed and voted upon, and transparent to the public. At this point it's unclear how many neighborhoods and people will be impacted by this, but there are thousands of sites within LA City boundaries. Mapping and analysis by volunteers estimates at least 2,100 NEW criminalization zones, totaling at least 46 sq. miles. The actual impact of the law is unknown because City Council has not done the work of determining the specific locations. The proposed mandatory enforcement within 500 feet of schools and daycare centers will have an even greater negative impact on youth and adults experiencing homelessness. Students and children are greatly impacted by homelessness and housing instability. Schools are an important community resource for supporting unhoued students and young Angelenos at risk of homelessness. This blanket expansion does not take into consideration how this could affect this population.
