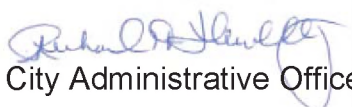

Subject: **2020-21 UNFREEZE RESOLUTION**

Section 4.132 of the Los Angeles Administrative Code provides that vacated positions, other than those of Officers of the City as defined by the Charter, may not be filled without specific authorization by the City Council. Therefore, I have prepared and attached the 2020-21 Unfreeze Resolution, which will provide such authorization subject to the Citywide Hiring Freeze. The attachment identifies the positions authorized in the 2020-21 Budget that are required to remain vacant should the Hiring Freeze be lifted. This list consists of the positions for which the City Council and Mayor reduced funding or that they identified for deletion in order to fund other purposes and positions approved subsequent to the enactment of the 2020-21 Budget, but effective July 1, 2020 (C.F. 20-0600).
