RESOLUTION

WHEREAS, California Vehicle Code Section 22507(a) authorizes local authorities to establish, by ordinance or resolution, the designation of certain streets upon which preferential parking privileges are given; and

WHEREAS, the Los Angeles Municipal Code (LAMC) Section 80.58 establishes the Preferential Parking Program; and

WHEREAS, LAMC Section 80.58(d) provides that Temporary Preferential Parking Districts may be established by Council resolution; and

WHEREAS, residents located on the blocks indicated below are faced with a lack of on-street parking throughout the day;

NOW, THEREFORE BE IT RESOLVED that the City Council, pursuant to Los Angeles Municipal Code Section 80.58, hereby establishes a Temporary Preferential Parking District, number to be assigned by the Department of Transportation, consisting of:

- North Boylston Street from West Temple Street to West Court Street
- North Boylston Street from West Court Street to Colton Street
- Firmin Street from West Temple Boulevard to West Court Street
- North Bixel Street from West Court Street to West Temple Street
- North Bixel Street between West Court Street to Colton Street
- East Edgeware Road from West Temple Street to Cortez Street
- East Edgeware Road from Cortez Street to Angelina Street
- East Edgeware Road from West Angelina Street to Court Street
- North Toluca Street from West Court Street to Colton Street
- North Toluca Street from Colton Street to Douglas Street
- North Toluca Street from Colton Street to Beverly Boulevard
- Douglas Street from West Court Street to Cortez Street
- Douglas Street from Cortez Street to West Temple Street
- Patton Street from West Temple Street to West Court Street
- Laveta Terrace from Glendale Boulevard to West Temple Street
- West Angelina Street between East Edgeware Road to Douglas Street
- West Court Street from North Boylston Street to North Bixel Street
- West Court Street from North Bixel Street to East Edgeware Road
- West Court Street from North Toluca Street to East Edgeware Road
- West Court Street from East Edgeware Road to Douglas Street
- West Court Street from Douglas Street to Patton Street
- West Court Street from Laveta Terrace to Glendale Boulevard

BE IT FURTHER RESOLVED, that upon approval of the TPPDs through the adoption of the Resolution, LADOT be authorized to post or remove parking restrictions on the blocks noted above with the following parking restrictions:


No Parking 6:00 P.M. to 8:00 A.M., 2-Hour Parking 8:00 A.M. to 6:00 P.M., Permits Exempt
