MOTION

The Sidewalk and Transit Amenities Program (STAP) delivers new bus shelters and transit-related amenities across Los Angeles to improve transit access, safety, and shade from heat. The STAP program continues to accelerate citywide deployment resulting in the need for additional field support for establishing new service points and constructing bus pads, particularly in areas that lack sufficient transit infrastructure. To enact this effort, the Bureau of Street Services (StreetsLA) and the Bureau of Street Lighting (BSL) require supplemental resources for design, field preparation, and direct construction. Funding appropriated to support the STAP program in the Reinvestment in Accessibility, Infrastructure, and Streetscape Enhancements for Los Angeles (RAISE LA) Fund shall be used to implement this work.

I THEREFORE MOVE that \$500,000 in Fund No. 67H, Dept. 50, Account No. 50EMST be transferred and appropriated to the Bureau of Street Services, Fund No. 100, Dept. 86 to the following accounts in the amounts listed below:
