I am also a vegetarian, unless I specifically know the source of the animal proteins I consume because I am deeply concerned with animal welfare. Externally, I can understand how some would be misguided into believing that the sport of rodeo is harmful to animals but nothing could be further from the truth. Those who participate in, and manage rodeo care deeply for animals. They would never introduce something that could cause them harm. Their jobs are very concretely founded in the care and welfare of the animal for multiple reasons, including profit. If the animal is injured, they loose profits. Those who participate in rodeo work closely with these animals. They create important bonds with them. They understand the animals far better than a spectator. Electric prods cause minimal stimulation. Quite frankly, it is the rare rodeo cowboy who himself has not been prodded by a joking friend. The electric prods are more of a training device to herd the animals into the chutes for performance, it causes mild discomfort. It is the most gentle form available to get them into the chute! Flank and bucking straps similarly cause a mild discomfort, but also a signal for the animal to buck, to perform. These animals are bred especially for this sport. It does not cause lasting harm to the animal. I find banning lariats and lassos to be absurd. They are the foundation of the sport. They do not harm the animals. The youth rodeo groups in which we participate include ample rules, specifically, for protecting the safety and well being of the animal. Participants are quickly disqualified if any activity could cause harm. This ordinance is a guise to pat oneself on the back, in an effort to declare agreement with animal rights. Rodeo is a sport of pure animal welfare. My horses get \$350 shoes every 6 weeks. I would never allow them to be injured by participating in rodeo. Rodeo participants spend thousands caring for steer and calves used in rodeo practice and performance. They are expensive to purchase and maintain. Similarly, an owner would never allow them to be caused injury or harm. When fully grown, these animals become commercially viable and valuable as they enter the food system. Animals used for bucking sports are absolutely premier in what they do. They are bred and cared for accordingly.

The sport of rodeo is growing, both financially and in participant numbers. Part of the allure, and the reason why I allow my children to participate, is because of the animals, because they get a chance to work with them. Working with them encourages, does not remove, empathy. In a world of future 'meta' technology, we need individuals who are grounded, who go outside, who work with animals, who understand how to care for them. Rodeo participants are the individuals who you WANT to have growing vour beef because they know how to care for them. If this ordinance is an issue in animal welfare, do not attack rodeo by approving this. Instead, you should be looking at large corporate animal protein producers, not rodeo participants. Please allow the citizens of LA to enjoy this sport by not approving this ordinance and allowing rodeo participants and hosts to do what they have been doing for 100 years, caring for and celebrating rodeo sport animals.

As an owner of professional equines and roping cattle I know first hand the special care it takes to keep my animals healthy and most of all happy. The western way of ranching and rodeoing is one of Americas oldest and most amazing lifestyles. After all, pioneers utilized this lifestyle to settle the majority of America as we know it now. The exception now is that we are better educated and aware of our animals welfare than in the 1800's. Because we chose this lifestyle we understand and respect our animals as they are the key to our advancement in the beef industry as well as rodeo. We have strict feed programs, utilize the best care and love for our animals. We have been taught to treat our animals as family regardless of our own needs. In no way do we torture our animals even though many perceive what we do as cruel. Rodeo animals are brought up as we are to do a specific task and are patiently trained and cared for in the process. We do not just rope any animal nor do we take for granted the role these animals play in our lives. Feeding, immunizing, health checks, doctoring every scratch that may appear and making sure they have proper and clean pens and cover from the elements are all part of our responsibility of owning an animals whether it is a roping steer, bucking horse/bull or a cow dog. Our animals get all the care that our children and ourselves get, quite often more care. Making sure these animals are healthy, safe and fed comes before I or my family has a meal or goes to bed is our responsibility and we take it very seriously. I have witnessed feed lots and other forms of animal processing for human consumption and I can honestly say our ranch and rodeo livestock are treated 1,000 times better than any animal kept and raised for most Americans food. I am deeply saddened at the ordnance that is attempting to be passed. As a rodeo competitor I know first hand the dedication, time, money, and care that we put into our animal. Competition animals, specifically horses, receive a stellar level of care. From specialized feed plans, joint supplements, vet care, dental care done every six months, farrier(hoof) care done every four weeks, assessed living quarters for reduced stress, all this and more are what our performance horses receive. They receive only the best care, physically and mentally because having a horse that is stressed or not feeling well is not to their benefit nor ours. The equipment(tack) we use is tailored to each horse. All horses have different builds and to keep them most comfortable custom tack is a must. All tack is assessed for the well being of the particular animals. Saddles and pads are assessed to ensure equal pressure distribution and shock absorption so that the horses back is comfortable. Bits are assessed for fit and level of training and comfort. Some horses enjoy "rollers" (small spinning rings) on the mouth piece of their bit so that they have something for their tongue to play with. I personally, thoroughly check my competition horses daily for any injuries or issues. They are groomed(brushed) daily. I constantly monitor their weight so that with any variation their feed can be increased or decreased. They are on Hyaluronic Acid for joint support that costs me a small fortune each year. In the summer they wear fly masks that not only keep the flies from bothering their eyes but also are equipped with UV protection. In winter they receive extra feed to keep weight on and create warmth. Their feet are trimmed every four weeks to maintain proper alignment and reduce tendon and joint stress. Their teeth are done every six ensuring all sharp points are taken away so that the mouth is not in discomfort. When we are at a rodeo, my horses have access to hav sacks and water any time they are not actively completing. They enjoy trailering to different locations and know exactly what to do for their various events. They enjoy all the other horses that they would not otherwise be around. Performance horses, I would argue, are much more balanced than a backyard horse pet. They thrive off of work and a having a job. They are able to adventure with their owner to

different locations and this creates a stronger bond between animal and human. They have better muscle tone from working out which is very important to an animal averaging 1000lbs. As owners we are constantly studying to learn new ways to keep our horses happy and healthy and not just for the short term, happy and healthy into their 30's. It is very important to keep rodeo and horse shows alive. It gives our horses and us a goal to head towards and a reason to train. It also helps our horses learn to be calm with different things which is directly related to their well being. A horse that is scared of new places and things because he has never been out, is not a very happy horse at all. We are a team our horses and us, we struggle together, overcome together, win together, goof off together, we are inseparable. So much of our life is together and to rob us of competition does not make one scrap of sense. Competition horses receive the highest standard of care and the most human/horse bonding time. A backyard pet horse doesn't receive multiple hours per day of human contact. It costs us a fortune to care for our horses the way we do, it costs us a fortune of time spent as well and to take away the end goal, the competition, the winning... our horses want it as much as us. Great competition horses are great because they love to compete. They get the rush like we do and they certainly know when they do a stellar job. They understand applause. I am asking you all, do not ban rodeo or competitions. If you are truly concerned about animal welfare you will not. Competition brings better care to horses. Competition horses receive above and beyond care and if there in no competition and they get turned into backyard pets the level of care will decrease exponentially. This is very distressing to me because two of my now competition horses I acquired from "backyard" homes and their care was non-existent. They were sick and unhealthy, unhappy and fearful of humans. Competition gave us a goal and competition helped them because the horses they are now, confident, balanced, enjoying human interaction, and healthy with adequate muscle tone.

Outside of the United States, Auckland, New Zealand, part of Brazil, Quebec, Canada, and the entire United Kingdom have instituted rodeo bans. The city of Los Angeles has become a national leader in protecting the rights and welfare of animals as can be seen with their recent fur ban. So many people are so misinformed about the sport. So many are uneducated. One example; Claims of the flankstrap and tieing testicles up to make them buck, not true at all. Most of the bucking horses are of the female gender. Have you ever yourselves witnessed a rodeo? Watch the animal athletes load into the bucking chutes, they load in, then they stand calmly for the most part as the human athlete prepares. Then once the human athlete is ready and the chute opens for the human and animal athlete, the livestock performs with his participate. Once the cowboy athlete is removed from the livestock, by being bucked off or by the other cowboys on horseback known as pick up men, the livestock generally quite bucking, the flank strap is removed and the animals are escorted from the arena. The roping and riding events have rules set in place to protect the livestock. Some of this bucking stock is valued at tens of thousands of dollars. The injuries and misconception come from compiled files over lengthy time. The human athletes suffer far more injuries in this sport than the animal athletes. Education about this sport can only be absorbed by those with open ears, open minds, and open hearts. Now, let me reiterate about the animal athletes and their caretakers, and the human athletes.. The animal athletes are the Beautiful Creatures that people are trying to shave. If these people that own these animals did not own them, other people would not get to see their majestic beauty. Trust me the people taking care of them are doing the utmost to go out of their way to keep these animals safe and protected. Life for all living beings is a great thing. Humans and animals alike. In this misunderstood sport the Cowboys are actually the caretakers for these beautiful animals. With out the cowboy the animals don't survive. With out the animals the cowboy does not survive. These laws and rules already address spurs, flank straps and electric prod usage. Penal code 596.7 already restricts the use of electric prods, flank straps are fleece lined or soft rope, and sharp spurs are prohibited and locked spurs are prohibited in saddle bronc and bareback events. We take great pride in our rodeo livestock. Our animals are often worth thousands of dollars and are bred for their job as a rodeo athlete. Items such as flank straps are not used to hurt an animal but for the safety of the animal and the rider. Flank straps are lined with fleece and never placed too tightly as the animal will not buck if that is the case. Spurs are not sharp as often indicated and electric prods can only be used in case of an emergency when the chute gate is open and the life of the animal and/or rider is threatened. Comments for Public Posting: Dear Members of the Council, as a lifelong Rodeo participant raised by rodeo parents, I feel that it is imperative for you to understand the true nature of rodeo. Rodeo stock, bucking along with timed event are treated almost like royalty. The cost of such animals runs in the 5 and 6 digits for bucking stock and several hundred for the timed event stock. Contractors know that without the GREAT stock they don't have a rodeo. For this reason, they are feed and cared for in the best possible way. I have heard "rodeo uneducated" people state that the flank straps work by "hurting" the animal in turn making them buck, this is simply not true. The flanks of animals are ticklish just like our arm pits, that is why they buck. Just go get on any broke horse and kick him in the flanks or squeeze him in the flanks and you will see what I mean. These bucking animals are bred to buck "more heart/grittier", most come from a long line of great buckers. Just like a line of great working dogs or show dogs. Now let's discus the timed event horse: roping, barrel and dogging horses. These animals are getting the best feed, supplements and veterinary care that there is along with a very intense exercise program. My hope and dream would be that parents would treat their kids as well as these animals are, if so, we wouldn't have any more child abuse in the world! Just like the rough stock animals, these horses are also bred for ability in the given event. Most of these animals LOVE what they are doing and have a great connection to their jockey. In my case when I walk outside my heading horse will meet me for his daily butt scratches and my barrel mare will come up and nuzzle me wanting her ears and eyes rubbed. Just like the rough stock, these great horses are selling for 5 and 6 figures. I myself was offered \$30,000 for my heading horse and I don't go to the big events, just all girl roping's and jackpots. You see it wouldn't make sense to not treat him for the true blessing and athlete that he is. The pro caliber horses are selling for way over \$100,000 before they are ever proven winners in the rodeo arena. As with anything there will always be rotten apples in every crate. I'm not going to deny that there are some people that shouldn't be allowed to own ANY kind of animal just like some people shouldn't be allowed to be parents. The answer is to go after those that are abusing the privilege, (yes animal ownership is a privilege, not a right) and to not punish the responsible, loving animal owners. Go after the

owners that have animals with no protection from the weather, not properly fed or watered and receiving no veterinary care. Yes, also go after the ones that are abusing animals with excessive "training". 50 years ago, the training methods were totally different than today's methods. We have learned from our predecessor's mistakes along with the awesome breeding programs that "less is more". In closing I just want you to try to understand what rodeo truly is. Maybe take a trip to one of the big stock contractors ranches and see just how things work or go to one of the pro timed event persons ranches and see what happens on a daily basis. As stated, before I'm not denying that there is abuse in the world, stay vigilant against the true abused animals which are generally found in people's back yards or hobby owners, and occasionally in the rodeo arena.
