The idea that western sports are inherently harmful to animals is a bald-faced lie; the animals, whether they be horses, cows, or any other animal that may be used in these types of events (such as goats or sheep) are not abused by their keepers. Rather, they are often taken care of early in the morning, before their human caretakers have even done basic self care tasks such as taking medication and eating breakfast. The animals are never purposely harmed by a responsible owner, and all their basic needs are then seen to. This extends into any events held, like rodeos, where animal welfare, contrary to the beliefs of certain "activists" that wish to ban the sports, is an extremely high priority, not only because the animals are the livelihoods of these people and an injury to them could be economically devastating, but also because these people do indeed deeply care for the safety and wellbeing of these animals. Because of this, certain tools made or known to cause pain, discomfort, or harm to an animal such as sharp spurs, wire tie-down ropes, and sharp or electric prods, are banned at all responsible rodeos nationwide, and anyone caught using these objects are reprimanded and removed from the grounds and/or have these items confiscated. Even rough looking rodeo sport, such as tie-down roping, team roping, and steer wrestling, are harmless tasks developed from wrangling animals safely for veterinary procedures. Plus, in the Equestrian realm, groups such as the Compton Cowboys provide a safe alternative for low-income, inner city youth to violent street gangs, and banning them would be extremely detrimental to the wellbeing of those communities. As a progressive, I believe in an equal, just world, one where America can be the great nation it is meant to be, without prejudice based on race, sex, religion, gender, sexual orientation, or culture, but that will not be achieved as long as we keep oppressing and shunning cultures, which does include Rural America and the people from it, to which this sport is important, and trying to end cultural sports such as rodeo, especially on such false premises like perceived, nonexistent harm to animals, and doing these discriminatory bans are harmful to all the oppressed, marginalized, and systemically disadvantaged groups in America.
