We nurture and care for their needs with wonderful nutritional diets, sound veterinary medical attention, and natural environmental dwellings. Some of our animals, which are raised for competition in rodeo, are nurtured from stock being bred, groomed, and trained for their particular best interests so as not to harm them or wrongly place them in an area where they may suffer harm. With the loving care we give to our animals, our children grow up to respect, admire, and care with utmost concern for the animal kingdom. Without the rural families and lifestyles, the raising, nurturing, and caring for horses, cattle, bulls, dogs, cats, sheep, goats and pigs, among many other species of animals, our society would be void of the greatest caregivers to the animal kingdom. To ignore this fact is to harm the best of what animals could have. Rodeo is a cultural event, celebrating the rich traditions found in the Hispanic and Black communities. Los Angeles has the largest Hispanic population, many of whom are descended from the Charros and Vagueros who helped settle the west. In particular, they were invaluable to the Texas cattle industry in the post-Civil War era. These cowboys made their way north into Colorado, Kansas, Missouri, and then eventually west to California. and the animals we love. I urge you to take into account the track record of the Professional Rodeo Cowboys Association (PRCA). The PRCA has had animal welfare rules in place since 1947 and currently have over 70 rules protecting the livestock used in currently sanctioned rodeos. The PRCA has also had a 99.9% safety rating for the past 4 years. If there are concerns about rodeo and rodeo-type events consultations should be conducted with actual experts in rodeo, animal welfare, and from independent large-animal veterinarians and then strongly considered. The initial action to have this ordinance written by the city attorney was presented and urged by animal rights activists, who are against all animal use. These extremists are working to ban all animal ownership including pets and animal agriculture, and this is just another step of incrementalism in their plan. These groups use emotional rhetoric to manipulate public opinion. They purposefully ignore facts and current animal welfare standards. If there are concerns about rodeo and rodeo-type events consultations should be conducted with actual experts in rodeo, animal welfare, and from independent large-animal veterinarians and then strongly considered. We urge you to take into account the track record of the Professional Rodeo Cowboys Association (PRCA). The PRCA has had animal welfare rules in place since 1947 and currently have over 70 rules protecting the livestock used in currently sanctioned rodeos. The PRCA has also had a 99.9% safety rating for the past 4 years. The Professional Rodeo Cowboys Association also has over 70 rules pertaining to the safety of the livestock and contestants. These laws and rules already address spurs, flank straps and electric prod usage. Penal code 596.7 already restricts the use of electric prods, flank straps are fleece lined or soft rope, and sharp spurs are prohibited, and locked spurs are prohibited in saddle bronc and bareback events. We take great pride in our rodeo livestock. Our animals are often worth thousands of dollars and are bred for their job as a rodeo athlete. Items such as flank straps are not used to hurt an animal but for the safety of the animal and the rider. Flank straps are lined with fleece and never placed too tightly as the animal will not buck if that is the case. Spurs are not sharp as often indicated and electric prods can only be used in case of an emergency when the chute gate is open and the life of the animal and/or rider is threatened. No one involved in Rodeo, or the western industry was consulted by the Los Angeles City Council before they pushed the drafting of the ordinance forward. At least take the opportunity to educate yourselves about the equipment and usage before passing an ordinance.
