My daughter and I both barrel race. During this winter weather we've been experiencing I spend most of my day caring for our livestock. Making sure they have extra feed that we can't afford do to hay prices. Making sure they have extra bedding for these frigid nights (single digits). Chopping ice in live streams and draining hoses for those with water tanks. I start at 7am and am lucky if I get in the house by 5 pm. The well being a comfort of my animals is everything. We had an oops this spring and I have 18 heifers calving out right now. I spend hours checking to see who is getting ready to calve and making sure they are in the calving barn when they do so we don't lose babies to frigid temps. Our horses get the best hay out there and are checked everyday for any health issues or injury's. When our ropings steers are retired, a few are sold and we keep several to retire in luxury. Right now I have 10 retired roping steers out with my herd of beef cattle. These steers get to eat and live out their natural lives fat and sassy. You see they are great protectors. I discovered this by accident a few years ago. One of them at a time will wonder off with a beef cow about to give birth. They will stay with her until the calf is born. Then when the time is right mama cow will head back to the heard. Those Corrientes will tip their horns and gently nudge the babies on the back to keep them pushed up to the safety of the herd. We haven't lost a single cow or calf to predators since I started running my retired roping steers with them. In LA there is much emphasis put on the entertainment industry. Now I have heard and read publications about children and women being abused and mistreated in the entertainment industry. Perhaps your towns main industry should be examined and shut down for the mistreatment of human lives. I have a cousin who moved there and wanted to become an actress. She met some really nice people and some that abused her in ways that she eventually left. There are bad people in every industry. It doesn't give anyone the right to do away with a way of life or take away a dream. This is a lifestyle. I have four children and they have all helped and learned

the importance of caring for livestock. My oldest has left home and become a farrier. He runs cows too, but he really wanted to learn how to help protect and take care of performance horses feet. My four year old goes out three times a day to care for her bottle calves. We put so much time and energy into caring for these animals. It is our daily way of life. LA please don't ban a lifestyle because of rumors you have heard. There are always a few bad seeds in every profession. Most of us who live this ranching and rodeo lifestyle give everything we have to caring for our animals. There are thousands of children out there just waiting to be a part of rodeo. Don't start the ball rolling that will take away their dreams. In my world every little boy wants to be Lane Frost and every little girl Charmayne James or Haily Kinsel. Thank you for your time.
