Many rules are in place to protect the bulls' well-being. In the interest of making an informed decision, please visit the bulls and see for yourselves that their welfare is not jeopardized in the sport of professional bull riding. Visitors are often welcomed, although they are supervised and time limited so that the bulls can eat and rest undisturbed.
