Dead Councilmembers,

Bob Blumenfield's relationship with Last Chance for Animals ("LCA") should be scrutinized. While Last Chance for Animals may exhibit a veneer of moderate animal welfare advocacy, their director Chris DeRose is clearly among the more prominent animal rights extremists in the region. Thus, their effort to classify rodeo instruments and tools as instruments of torture without establishing a clear protocol to support that designation raises concerns by concerned community members who feel their rights are being violated as the Council prepares to adopt the proposed Rodeo Ban.

Beyond a survey and limited testimony of a sole veterinarian, Blumenfield has failed to submit data that warrants or justifies the Rodeo Ban. More importantly, the process has been riddled with poor community and stakeholder engagement that is wholly inadequate coming from this agency.

The most glaring issue is the failure to classify *all* eligible equestrian events within city limits as part of this ordinance. The absence of polo and hunter-jumper equestrian events indicates a clear bias which favors one equestrian tradition over another.

Meanwhile, Mr. Blumenfield has gone to great lengths to dismiss opposition to the proposed ordinance by insinuating that all criticism against the proposal are paid industry lobbyists. It is important to clarify that the condescending demeanor of the Councilmember constitutes an ongoing effort to silence the voices of working-class Latinos, Blacks, and Native Americans.

Mr. Blumenfield suggests that his "constituents" within animal welfare advocacy circles are much more numerous than opponents of the Rodeo Ban. Again, the community is concerned the ordinance is *even* being considered for a vote given the lack of data that corroborates the alleged animal abuse. As constituents we believe the Council should due its due diligence and OPPOSE the motion.

There is a distinction here, though, which is the pro-Rodeo effort is fighting to preserve an existing culture and sporting practice. Blumenfield, who is

proposing to eliminate rodeo altogether, has tailor-made an ordinance that will eradicate jobs and equestrian events to match *his* beliefs. This should have necessitated a higher burden in proving that current regulation is insufficient and to offset the lack of transparency and input.

Community members questioned the appropriateness of this entire process and whether it was based on an identifiable framework or a coincidental campaign of last chance for animals. This apparent effort to collude with a troubling special interest group has allowed that special interest an unprecedented opportunity to push a narrow policy agenda.

The actions of Mr. Blumenfield raise valid concerns as to whether the Council is further perpetuating racial bias within the decision-making process of the chambers. If we review articles, such as those written by LA Mag, it states:

...Blumenfield said that anecdotal evidence runs counter to what his office has seen and heard from Angelenos.

'We have gotten tens of thousands of people contacting us in favor of this. The animal welfare community is not only active, it's extremely large in Los Angeles... If you actually look at the letters and the calls that everyone on the council is getting, the animal welfare folks are way more numerous and they're actually Angelenos.'1

However, letters, such as that submitted by Dale Gibson of the Equine Advisory Committee challenged Blumenfield:

Los Angeles has an extensive horse culture. An estimated 90,000 horses reside in the city and county, said Dale Gibson, president of the city's equine advisory committee.

He accused the <u>council</u> of failing to consult with the panel on the motion, which he said would not only

'crush dreams of our young riders, but will push another multibillion-dollar industry out of <u>Los</u> Angeles.'

'These animals are fed and cared for at the highest levels to ensure long careers,' Mr. Gibson said in a Feb. 10 letter to the <u>council</u>. 'In exchange for a few seconds of riding, bucking, or roping, they are accorded a long and productive life.²

Not only has there been poor due diligence within this process, but also a failure to consider language access accommodations for constituents at every juncture prior to consideration of this matter.

Mr. Blumenfield's declarations not only demonstrate a dismissive view but raise concerns that the proposed Rodeo Ban ordinance changes the designation of a life experience—one that is very much shaped by the experiences of working-class communities of color—by representing this same conduct as "cruelty" towards animals.

The impact of this reclassification resulting in further disenfranchisement of key constituents. I would urge the City Council to investigate this matter. According to Form 990 filings with the IRS, Last Chance for Animals earned \$3,134,535 for the fiscal year ending in December 2021.³ The operations that have played out are not isolated to concerned animal welfare activists, but rather, a concerted campaign by well financed political operatives to set a precedent for a special interest lobby.

Blumenfeld's Close Working Relationship to LCA Warrants Scrutiny
The organization's methods and motives come from its founder Chris
DeRose who founded LCA in 1984. While DeRose considers himself a
"leader" in the animal extremist space, he has virtually no experience with
animals and livestock. He does, however, have a Hollywood background
and acting experience.

DeRose naturally follows the usual talking points of extremists in the media. In one instance he compared a stray dog being taken to an animal shelter

to a child being dropped off at an orphanage. DeRose claims he wishes to fight animal cruelty non-violently. However, like so many others in this space, he considers himself above the law and has "proudly" served time in jail for a high-profile break-in at a University of California-Los Angeles research lab.

LCA Agenda and Mission

Last Chance for Animals is an organization that considers its work to be "investigating, exposing, and ending animal exploitation." As such, LCA abides by the same general rules of the extremist movement. They believe that animals exist for their own reasons and should not be engaged in any service to humans and therefore oppose any usage of animals for food, clothing, entertainment, or scientific advancement.

In the political arena, LCA works to push legislation, ordinances, and campaigns which will further their agenda. They also actively support lawmakers whom they can influence with their agenda. According to their website, their philosophy is, "To enact humane laws, we need to elect humane lawmakers."

Much of their political action is leveraged and centered around petitions, swaying politicians, and public protests. They rely heavily on the use of public petitions and misinformation spread through undercover footage and social media.

LCA's Extremist History

LCA maintains a list of movements they have publicly supported. Their website lists campaigns that include fighting laws that protect farmers and ranchers from ideologues who seek and gain employment with the sole purpose of discrediting animal agriculture. The group also promotes the banning of puppy breeding, lab animal transport, elephant sanctuaries, zoos, and more. Right in their own backyard, LCA has pushed their agenda on the LA Zoo's elephant exhibit and supported other California bans. On the national level, LCA was among the many groups that made false claims against Ringling Brothers Circus and worked to ban the circus from performing in Los Angeles and other cities. The group also aligned with fellow animal extremists Grey2K to end all Greyhound racing in the U.S. under the Greyhound Protection Act H.R. 3335.

Rodeo is the New Target

With the goals accomplished of banning the circus and greyhound racing, the group has now set its sights on other forms of animal exhibitions. Rodeos are now in the top spot and center of their agenda.

In 2021, LCA first put out a petition calling for a ban on rodeo events in the city of Los Angeles. This comes right on the tail of the Los Angeles City Council passing a vote which asked the Los Angeles City Attorney to write ordinance language that will ban the use of equipment used in horseback riding, training, and handling of livestock and animals as well as rodeo events.

On LCA's petition website, they erroneously call rodeo events "exhibitions of animal cruelty" and cite the sport as using "tools of torment." This characterization is troubling for many reasons. The City animal services website defines animal cruelty as the following:

The California Penal Code defines animal cruelty as the malicious or intentional maiming, mutilation, torture or wounding of a living animal. Any person who overworks, tortures, torments, deprives of necessary food, drink or shelter, cruelly beats, mutilates or cruelly kills an animal is guilty of a misdemeanor or felony. Any person who possesses or trains a dog with the intent to engage the animal in exhibition fighting, as well as any person who is knowingly present as a spectator at an exhibition of fighting of dogs, is guilty of a misdemeanor. *In addition, any person who willfully abandons any animal is guilty of a misdemeanor.*⁴

Here, the above definition refers to animal cruelty as either malicious or possessing intent. The cruel treatment can also be inadvertent in some cases, but what stands out is that the classification for cruelty towards animals requires awareness of the harm being inflicted.

Given the cultural and lifestyle roots of rodeo and charreria, a participant would be aware of the harm because a.) having complied with the rules and regulations in place, they would not be in a position to harm the animal,

or b.) they would be ineligible from ever participating in rodeo activity without violating the provisions of that would make them in violation of engaging in animal cruelty.

The implications from a criminal justice standpoint are concerning. This ordinance could be broadly interpreted with minimal probable cause and would effectively punish someone for participating in a cultural activity. Here we look at the assessment by a sociologist of vegan extremist movements and their relationship to white supremacy.

White Veganism

...[White] Rank-and-file activists fail to consider how anti-speciesist comments could offend or even oppress disenfranchised humans. Because privilege tends to be invisible to those who have it, this propensity to hurt others frustratingly does not register with many white vegans.

This is a pivotal problem because the Nonhuman Animal rights movement regularly targets the actions of marginalized groups as "low-hanging fruit."

While white vegans may not be conscious of this fact, the speciesist actions of minorities are easy for the movement to pick on because society at large already oppresses these populations. Campaigns that target minorities are more likely to garner support from a white supremacist public because suspicions of Nonhuman Animal cruelty become yet another reason to discriminate. Examples include dog fighting, cock fighting, bear baiting, fur wearing, the consumption of dogs and cats, whale hunting, poaching, and hoarding. These are all traditionally associated with marginalized demographics such as lower-class persons, women, people of color, and non-Westerners. Vegan researchers have noted that it has typically been these forms of speciesism that the movement rallies behind, while the actions of society's privileged go ignored or under

resourced. Racist campaigns resonate in a racist society.

Moral Relativism

Anti-racist vegans are sometimes charged with "moral relativism" when challenging the presumed race neutrality of anti-speciesist claims making.

- ... "Color blind" vegans retort that pro-intersectional vegans must not care about Nonhuman Animal suffering. Nonhuman Animals, they argue, are left vulnerable to protect political correctness.
- ...The "moral relativism" defense is merely a deflection that seeks to protect the status quo and avoid critical examination. Nonhuman Animal suffering is thus exploited and objectified to protect the superiority of white veganism.
- ...The argument is only that creating single-issue campaigns that sensationalize the behaviors of people of color is racist. These campaigns reflect white privilege in that they provide white vegans the power to judge others as lesser and protect the ingroup sense of superiority. Such an approach is offensive to marginalized groups. It exactly explains why the Nonhuman Animal rights movement is overwhelmingly white and has historically had huge difficulties building links to other movements.

A White Supremacist Origin

People of color are institutionally oppressed by a racist criminal justice system which continues to believe that Brown and Black peoples are inherently cruel, evil, and in need of control. Should the vegan project be complicit with this dangerous stereotyping? Surely not, as the animalizing of people of color is not only an injustice to people of color, but also reinforces the cultural belief that the animal is bad.

Moving Forward

... When white vegans insist on avoiding a racialized lens, they actually underscore veganism's racialized nature. You see, white is a race, too, and protecting its supremacy in a social movement is a political act with consequences. Veganism is not, never was, and never will be "color blind." White vegans can advocate for other animals in ways that do not ostracize or alienate underprivileged people (see the work of Dr. Breeze Harper). This will involve self-reflection and awareness when planning. It also requires dialogue with those who have historically been denied participation in decision-making [emphasis is mine].⁵

When viewed through this lens, the actions of Bob Blumenfield raise concern as to whether true dialogue waws considered as part of this ordinance or if an equity analysis might be warranted to affirmatively support that the actions taken by the Council did not contribute to, or reinforce, white supremacist views.

The observation is made because of the close friendship between Blumenfield and Chris DeRose. The nature of this friendship should be investigated prior to any Council vote. Chris is quoted in the LA Times, acknowledging his extremist views:

"The animal problem is just so big," DeRose said. "Maybe in 100 years, people will realize that a mouse has as much right to live as a human being." In the meantime, DeRose said, animal-rights activists may become more aggressive. He said he does not encourage arson, which has occurred at several animal-research facilities, but if no one is hurt, "I'm behind it," DeRose said.

"In the civil rights movement, they got disgusted and started fighting back," DeRose said. "I've been for passive resistance and civil disobedience all along, but you can only be pushed so far."

If you go on the Last Chance for Animals website, you'll notice a special page dedicated to Jonathan Paul, who is identified as a member of the Animal Liberation Front (ALF). The webpage states:

Jonathan was involved in animal liberations through the Animal Liberation Front (ALF), an international, underground organization of animal rescuers who seek to free captive animals from research labs, fur farms, factory farms and anywhere else animals are being caged and mistreated. For two decades, Jonathan liberated dogs, cats, monkeys, mice and rabbits from research labs where they were held in tiny cages to be surgically operated on (often without anesthesia) for their entire lives. He released wild horses that were captured by the Bureau of Land Management and auctioned to the highest bidder to be slaughtered for their meat.⁷

It should be cause for concern for members of this Council that the onus of the *corroboration* used to support this ordinance, largely stems from a well-financed animal rights extremist fringe group, which has reliably called upon Blumenfield to deliver. While some animal welfare advocates might harbor sympathies for individuals such as Chris DeRosa, I would recommend Councilmembers scrutinize the role and influence Chris DeRose has had in shaping the ordinance, and whether extremist ties by Mr. Blumenfield prior to any vote to adopt this ordinance might upholding white supremacy and other forms of institutionalized racism.

The youth athletes who participate in rodeo learn about a livelihood from a young age. It's not just a sport. It is a community. Ranchers, farmers and rodeo are entwined. A community that provides food and resources. The skills and benefits from learning accountability, discipline, caring for another animal, respect, hard work, teamwork and dedication are life changing. Generations have passed down their skills and this livelihood and lifestyle. This ban attempts to eliminate a problem that does not exist. Safety and humane practices are already taught and enforced. In fact I would argue you will not meet another group of individuals who respect animals more or treat them in higher regard. There are already laws in place regarding rodeo equipment and usage in California. The Professional Rodeo Cowboys Association also has over 70 rules pertaining to the safety of the livestock and contestants. These laws and rules already address spurs, flank straps and electric prod usage. Penal code 596.7 already restricts the use of electric prods, flank straps are fleece lined or soft rope, and sharp spurs are prohibited and locked spurs are prohibited in saddle bronc and bareback events. We take great pride in our rodeo livestock. Our animals are often worth thousands of dollars and are bred for their job as a rodeo athlete. Items such as flank straps are not used to hurt an animal but for the safety of the animal and the rider. Flank straps are lined with fleece and never placed too tightly as the animal will not buck if that is the case. Spurs are not sharp as often indicated and electric prods can only be used in case of an emergency when the chute gate is open and the life of the animal and/or rider is threatened. No one involved in Rodeo or the western industry was consulted by the Los Angeles City Council before they pushed the drafting of the ordinance forward. At least take the opportunity to educate yourselves about the equipment and usage before passing an ordinance. There are a number of businesses that count on the Professional Bull Riding and rodeo related activities at venues like the Staples Center that draw capacity crowds for their business. Those restaurants and businesses that gain income from the economic impact of these events will see their bottom line

negatively impacted. As stated previously businesses, athletes, farms, ranches, generations are all impacted by this decision. I oppose the ban and strongly discourage any action taken to ban rodeos in LA CITY OR LA COUNTY.
